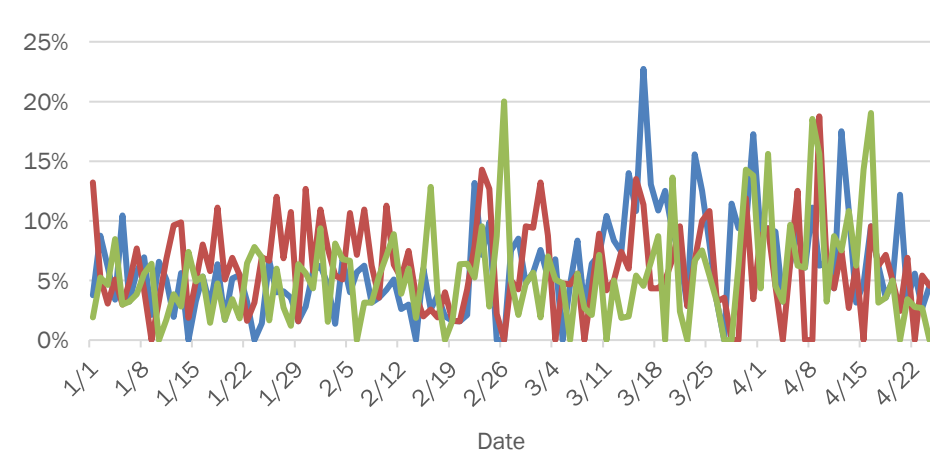


Emergency department (ED) chief complaint and admission data for Bradford County

Daily percent of ED visits that mention cough, fever, or shortness of breath

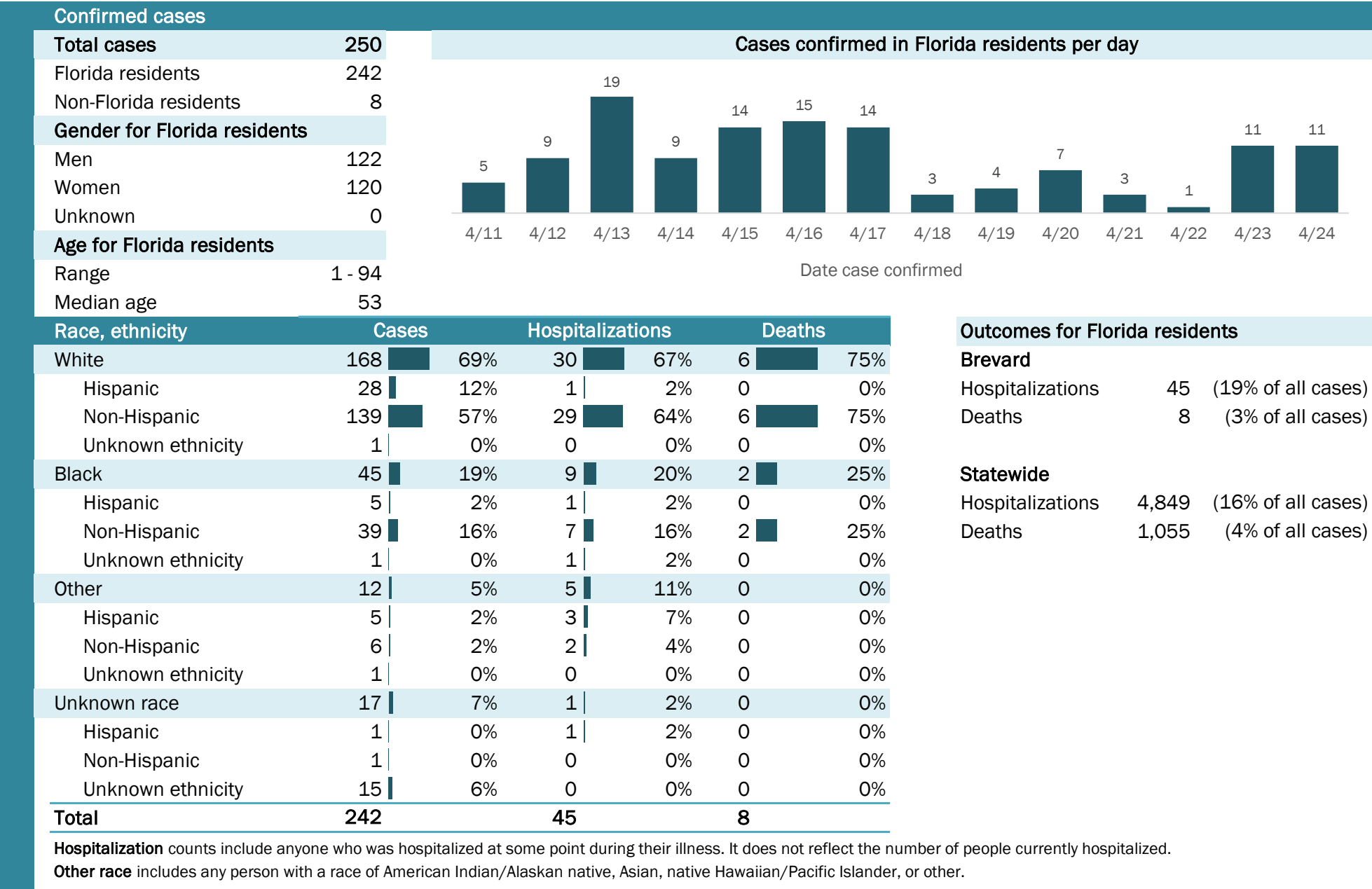

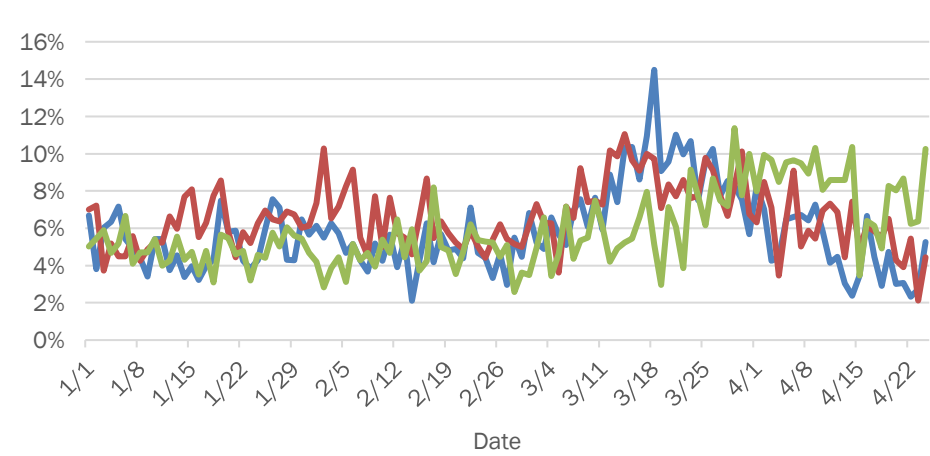


Emergency department (ED) chief complaint and admission data for Escambia County

Daily percent of ED visits that mention cough, fever, or shortness of breath

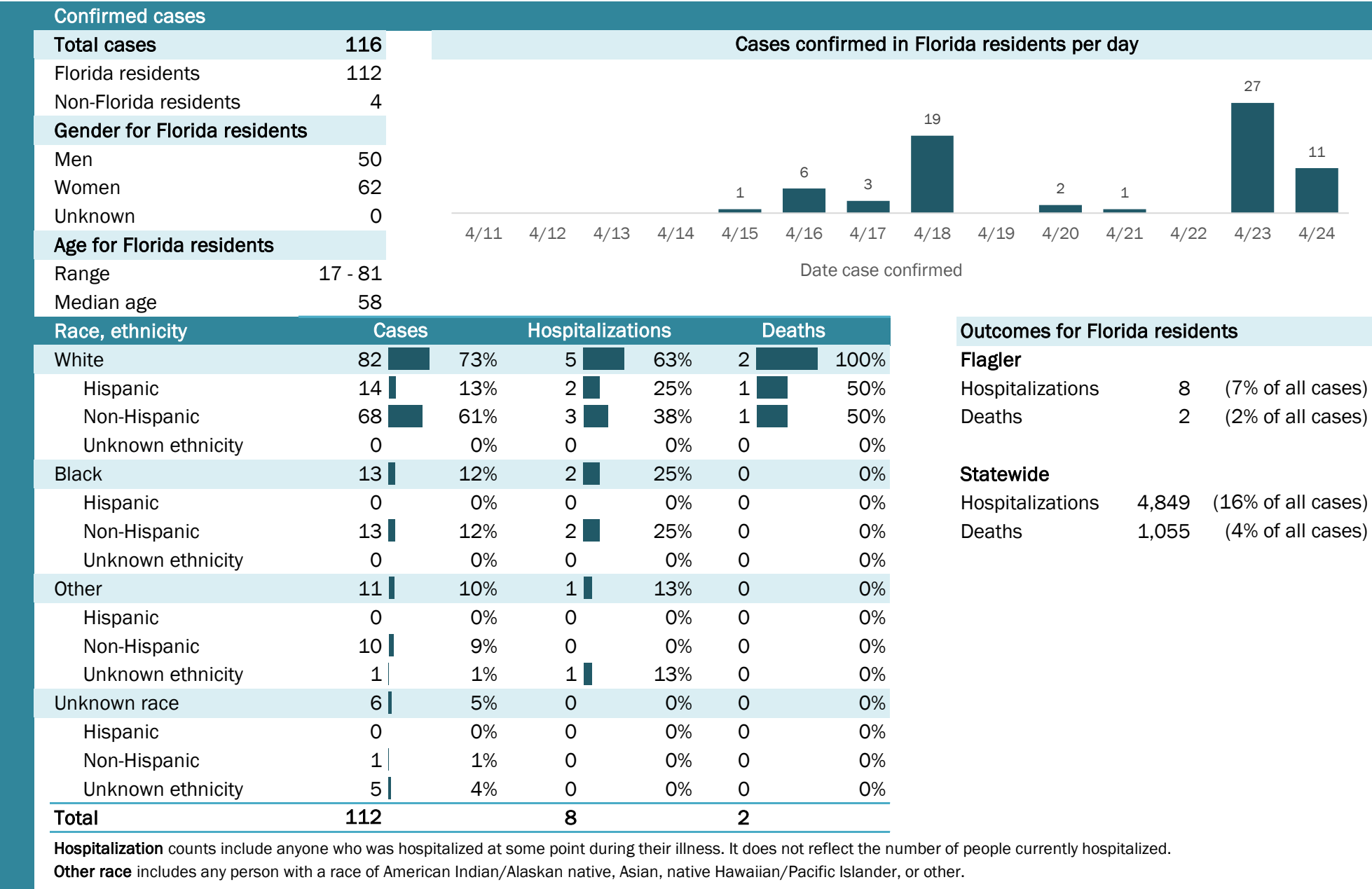

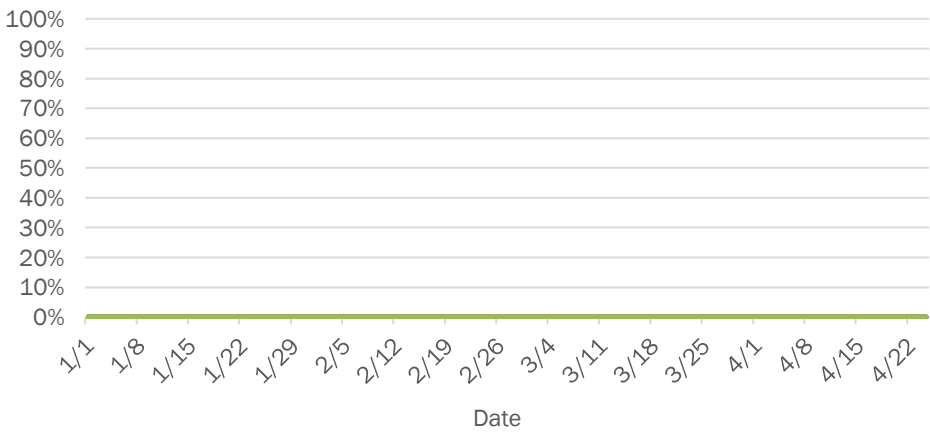


Emergency department (ED) chief complaint and admission data for Franklin County

Daily percent of ED visits that mention cough, fever, or shortness of breath

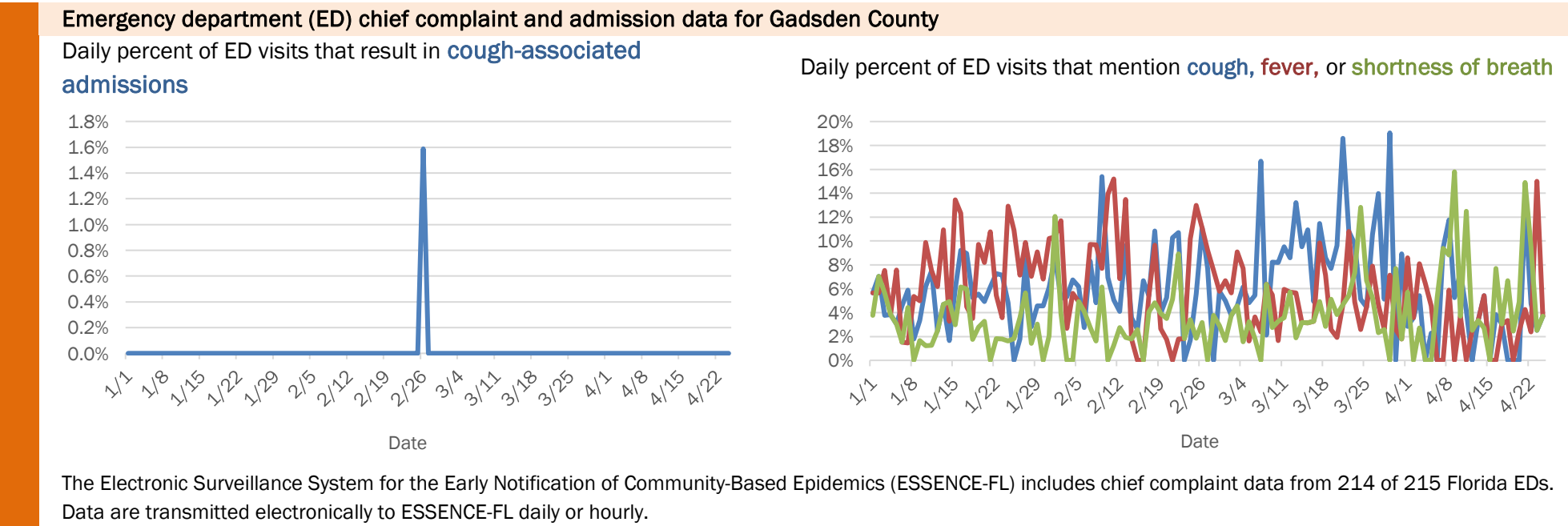
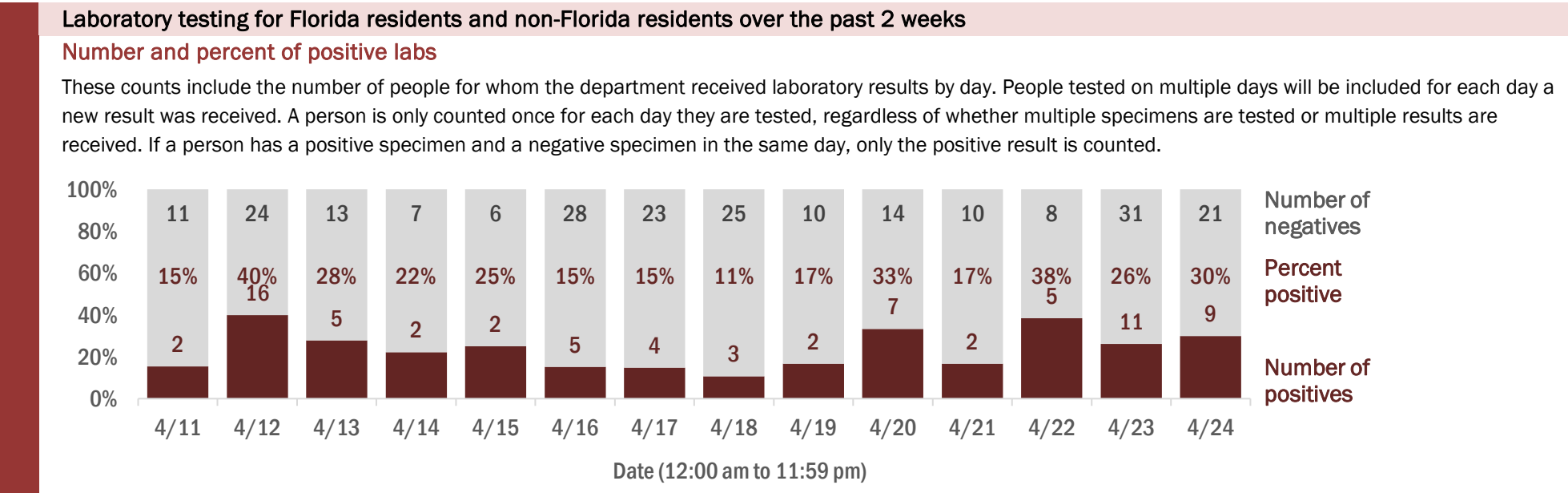
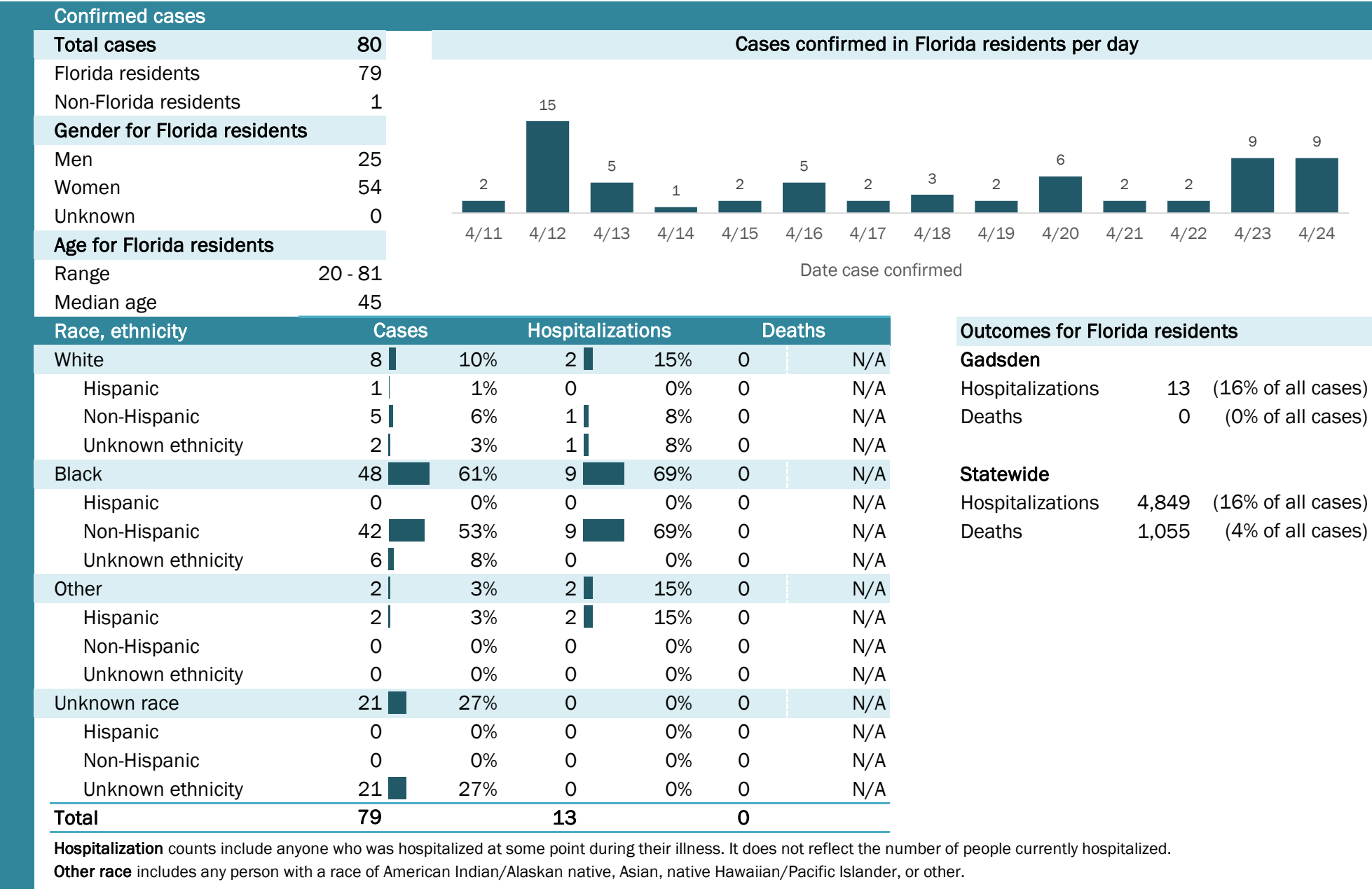

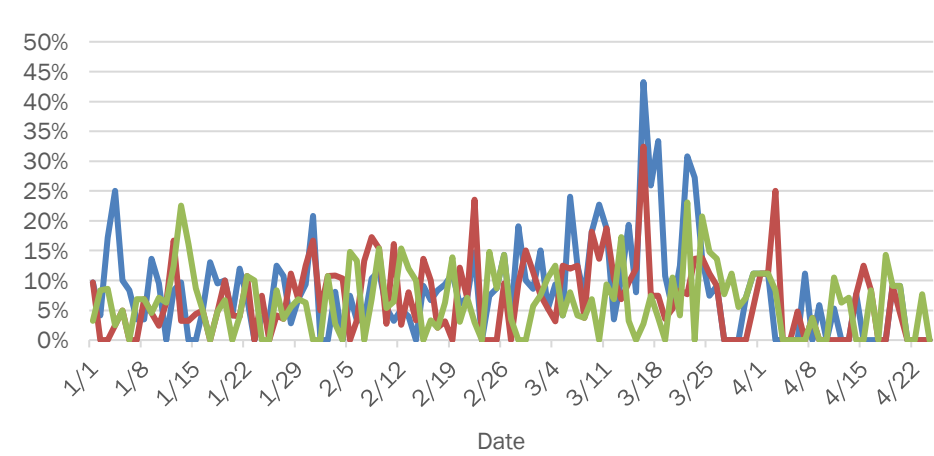


Emergency department (ED) chief complaint and admission data for Gulf County

Daily percent of ED visits that mention cough, fever, or shortness of breath

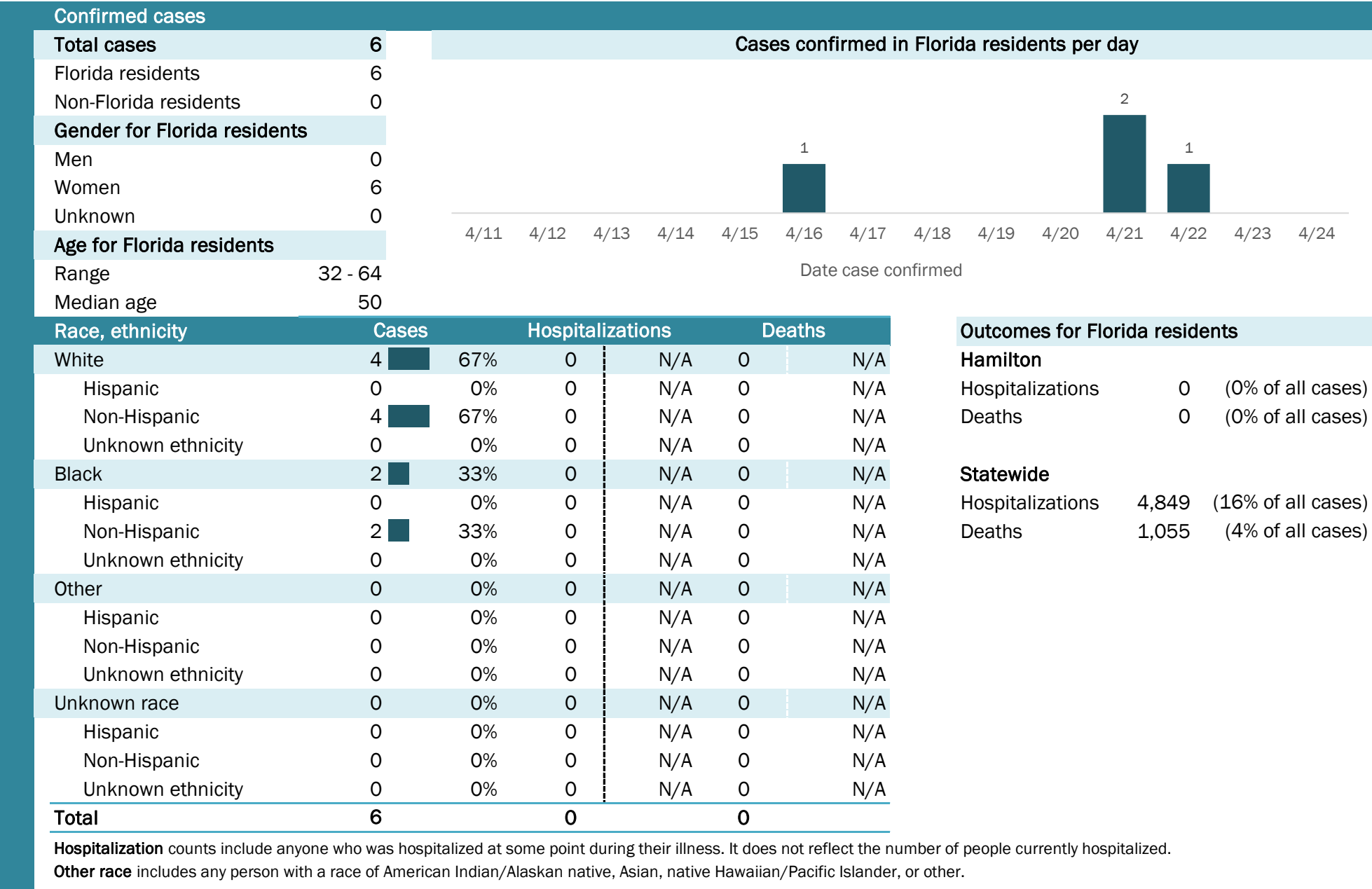

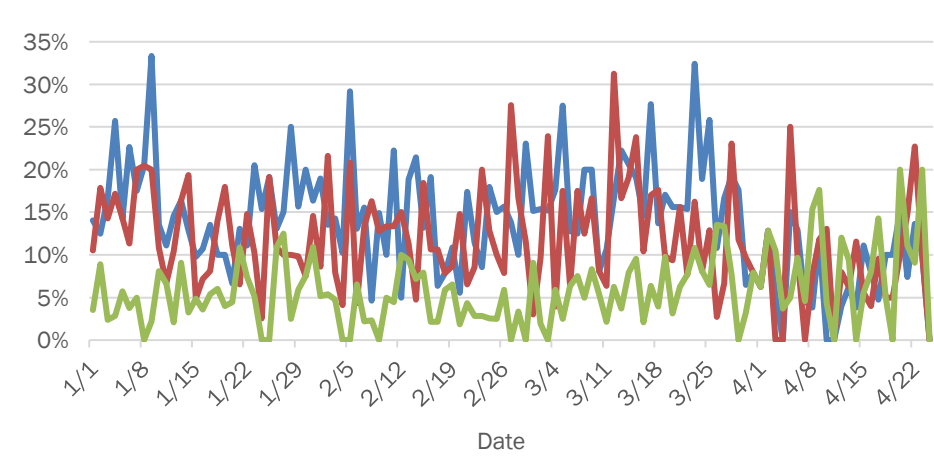


Emergency department (ED) chief complaint and admission data for Hardee County

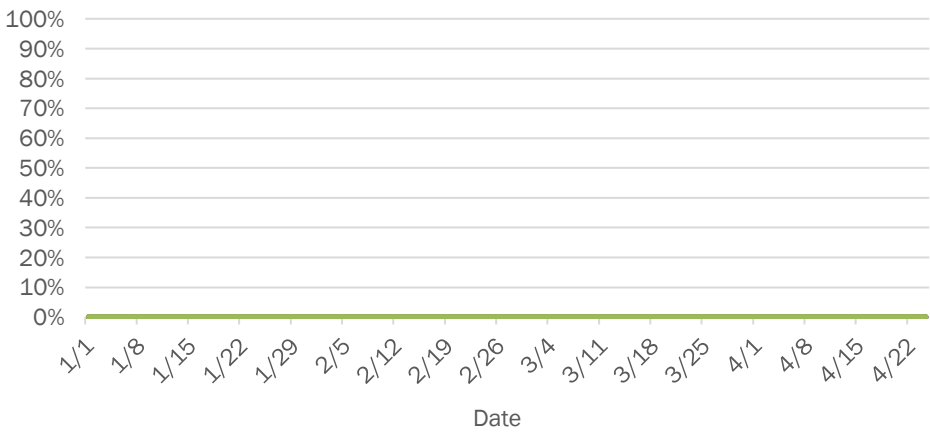


Emergency department (ED) chief complaint and admission data for Lafayette County

Daily percent of ED visits that mention cough, fever, or shortness of breath

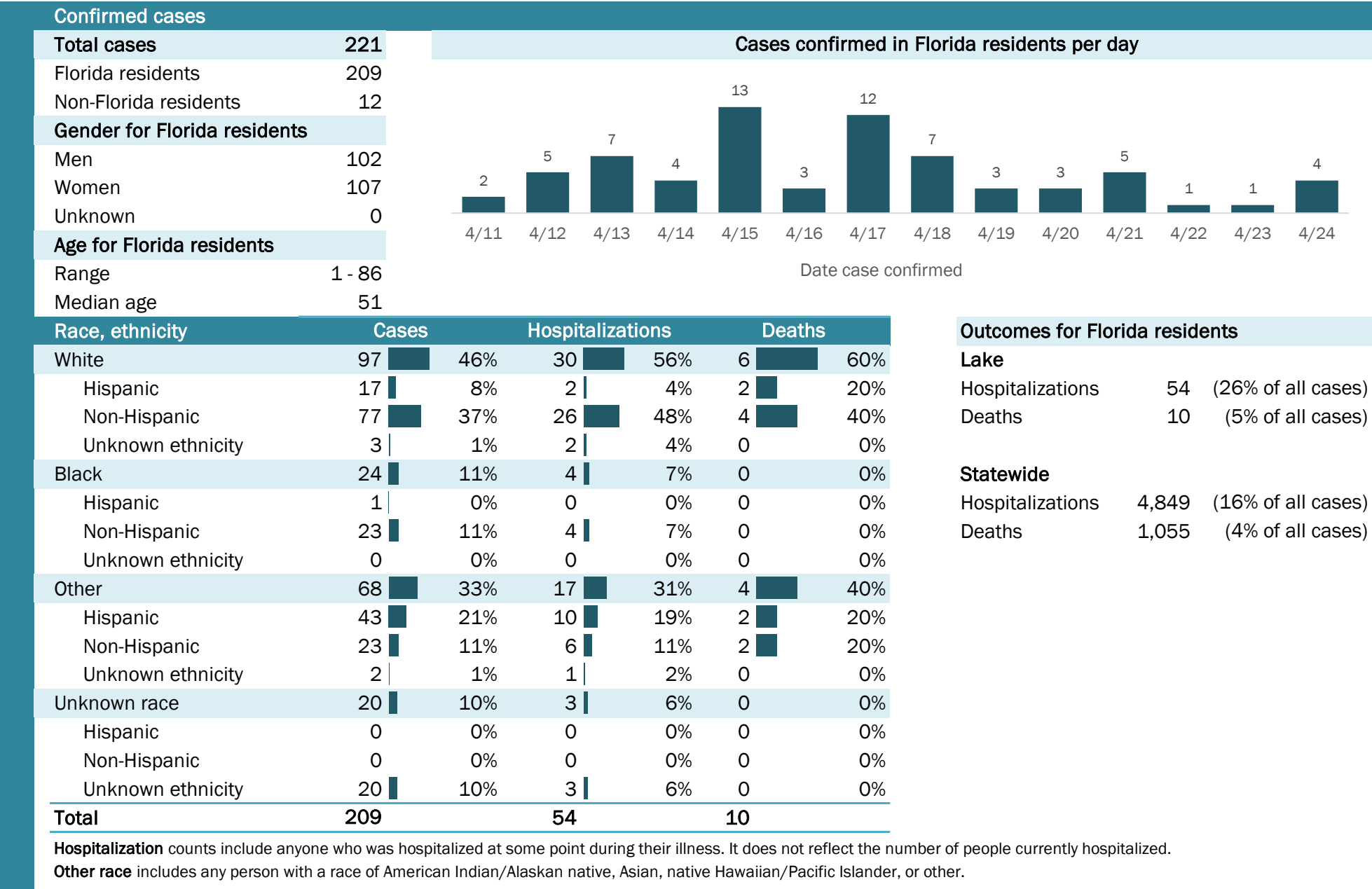

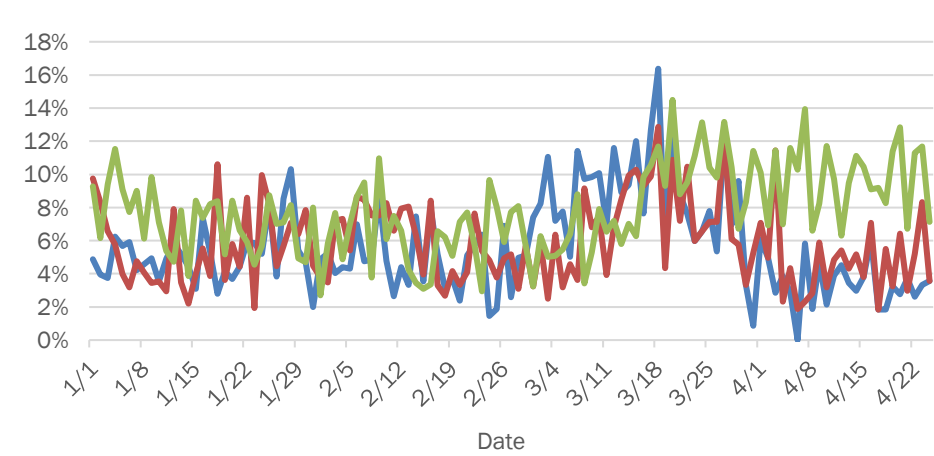


Emergency department (ED) chief complaint and admission data for Martin County

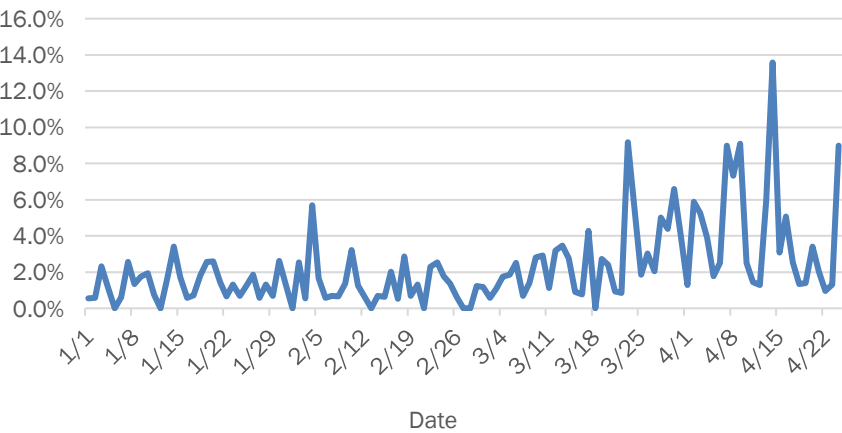

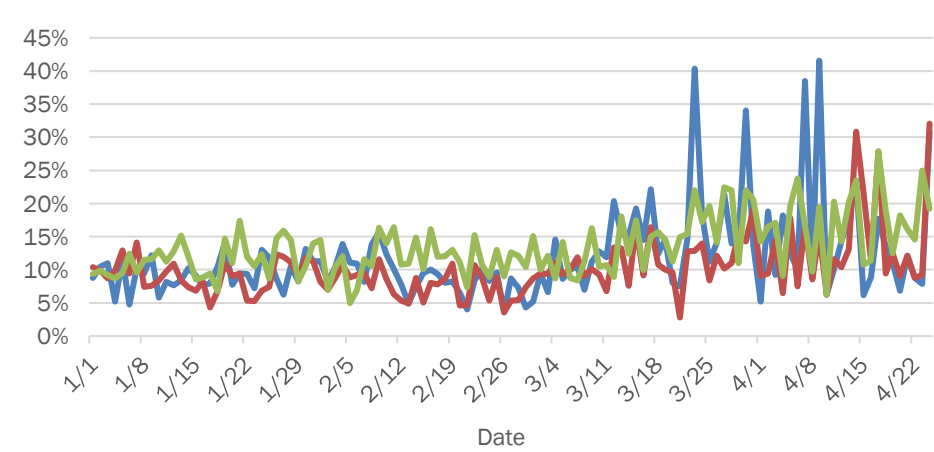


Emergency department (ED) chief complaint and admission data for St. Johns County

Daily percent of ED visits that mention cough, fever, or shortness of breath

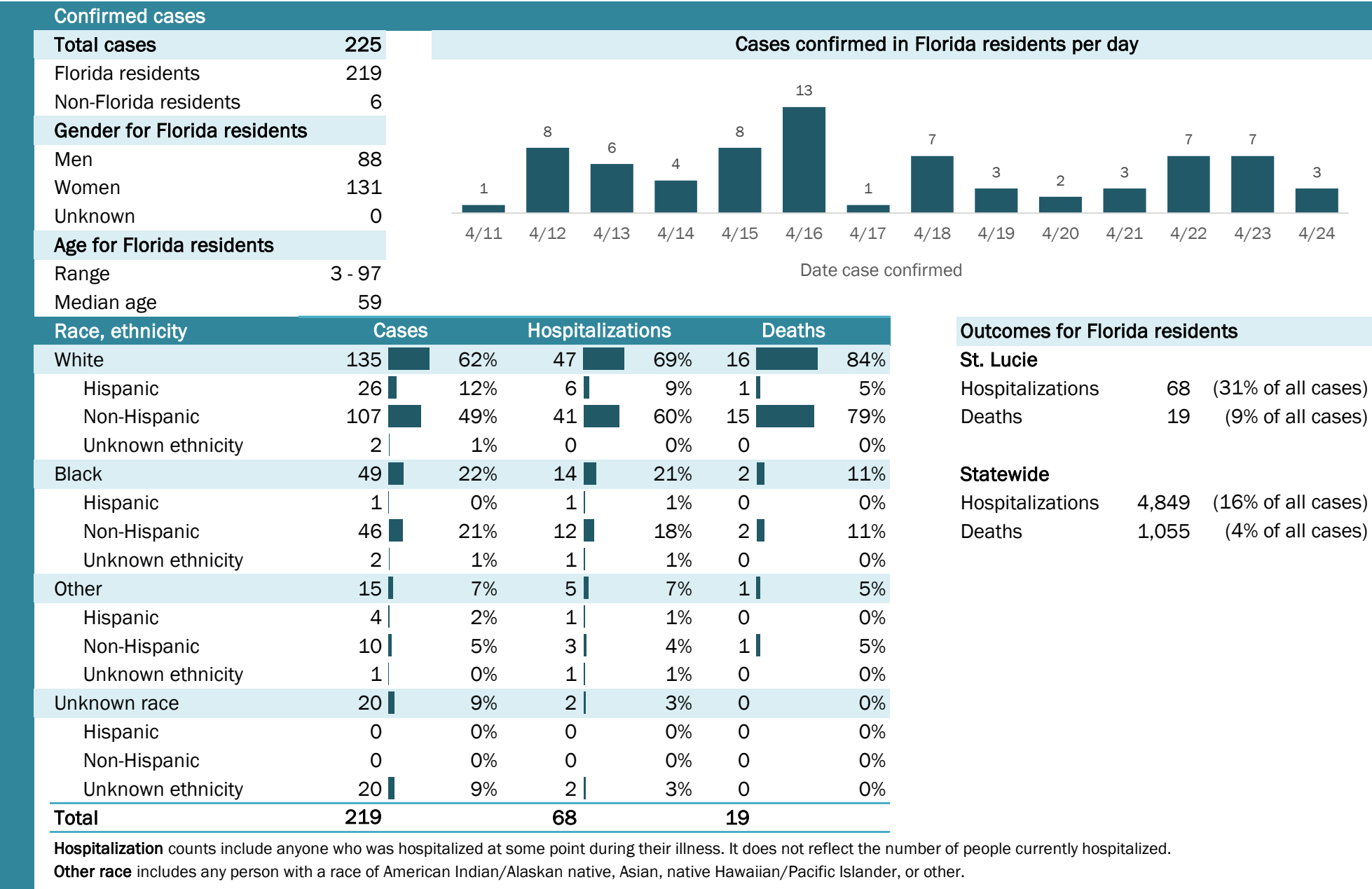

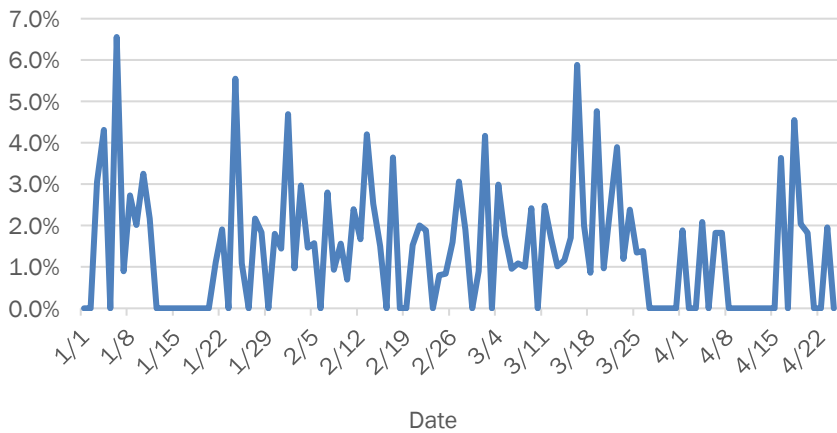

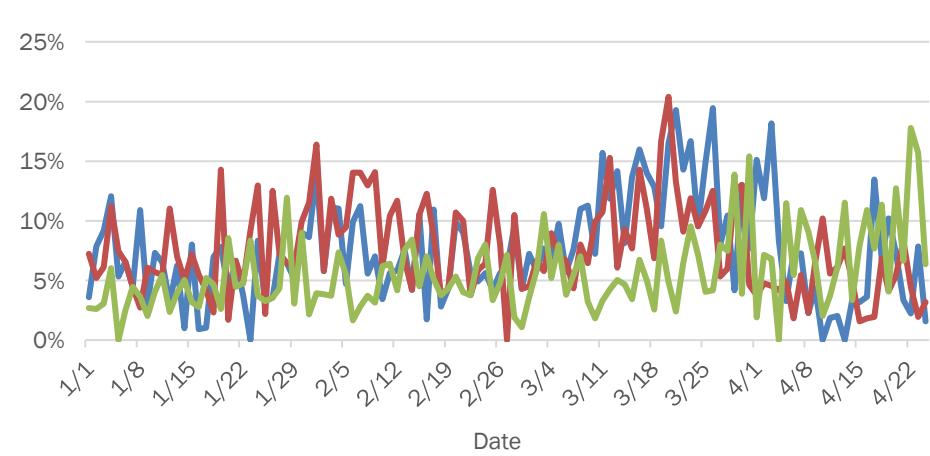


Emergency department (ED) chief complaint and admission data for Walton County
