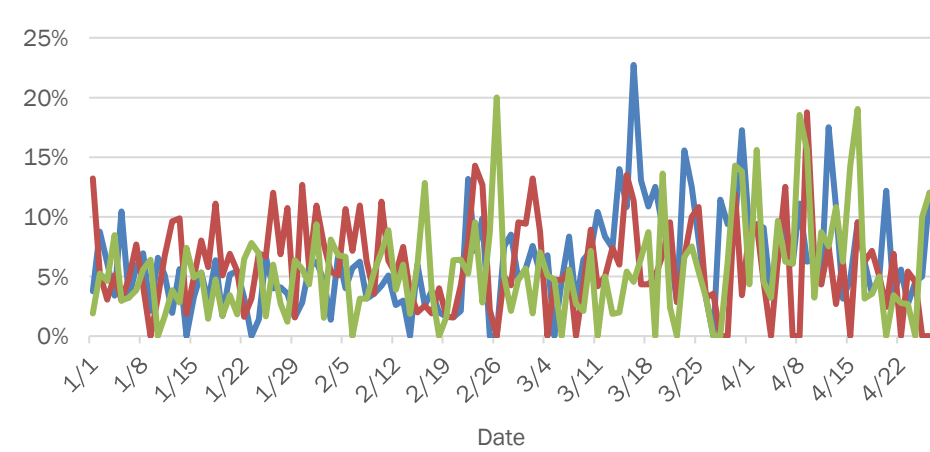


Emergency department (ED) chief complaint and admission data for Bradford County

Daily percent of ED visits that mention cough, fever, or shortness of breath

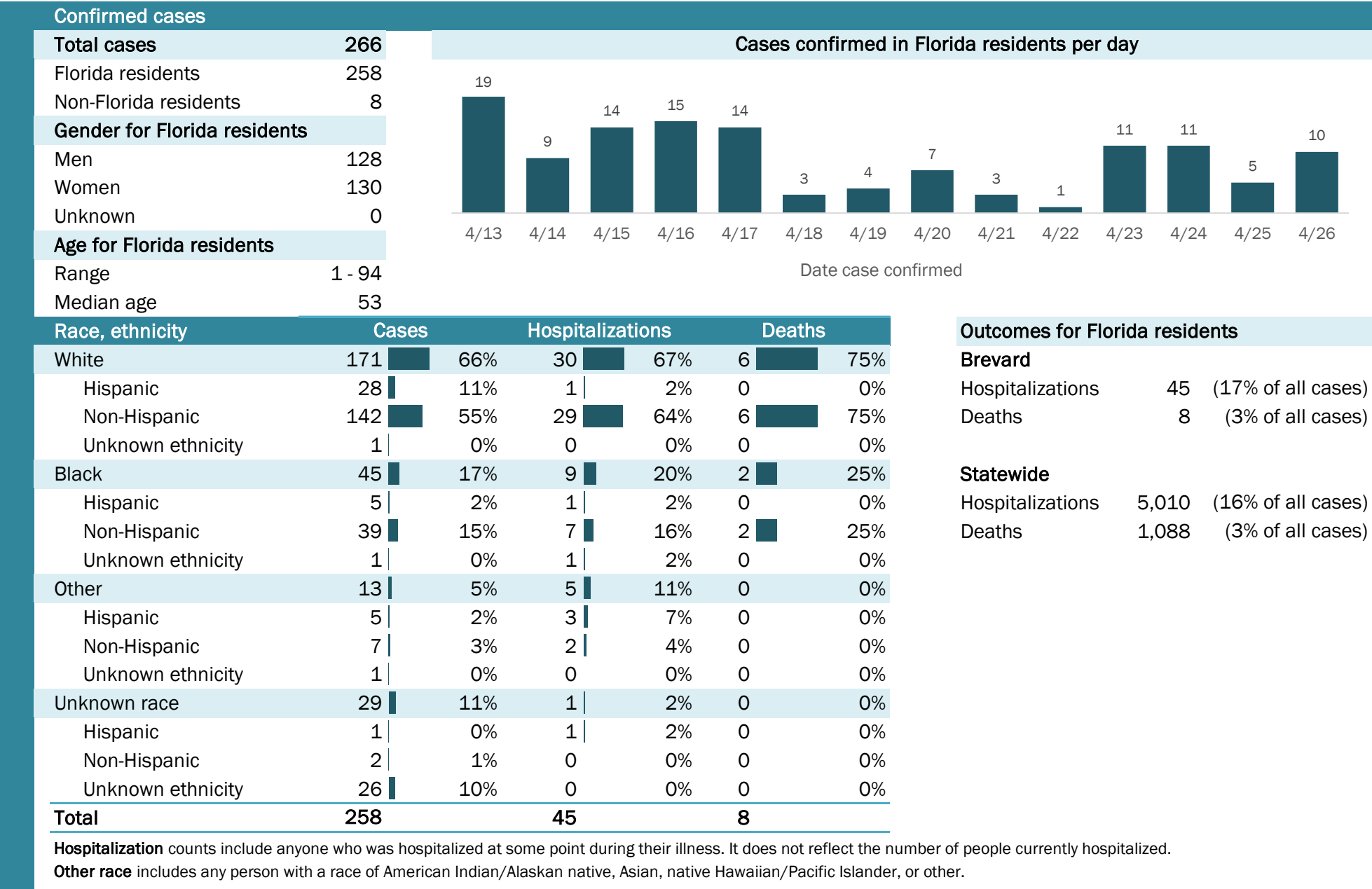

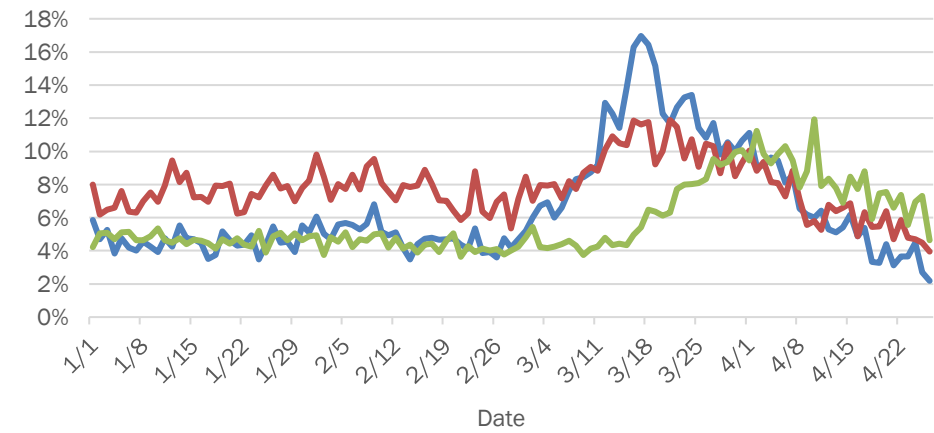


Emergency department (ED) chief complaint and admission data for Broward County

Daily percent of ED visits that mention cough, fever, or shortness of breath

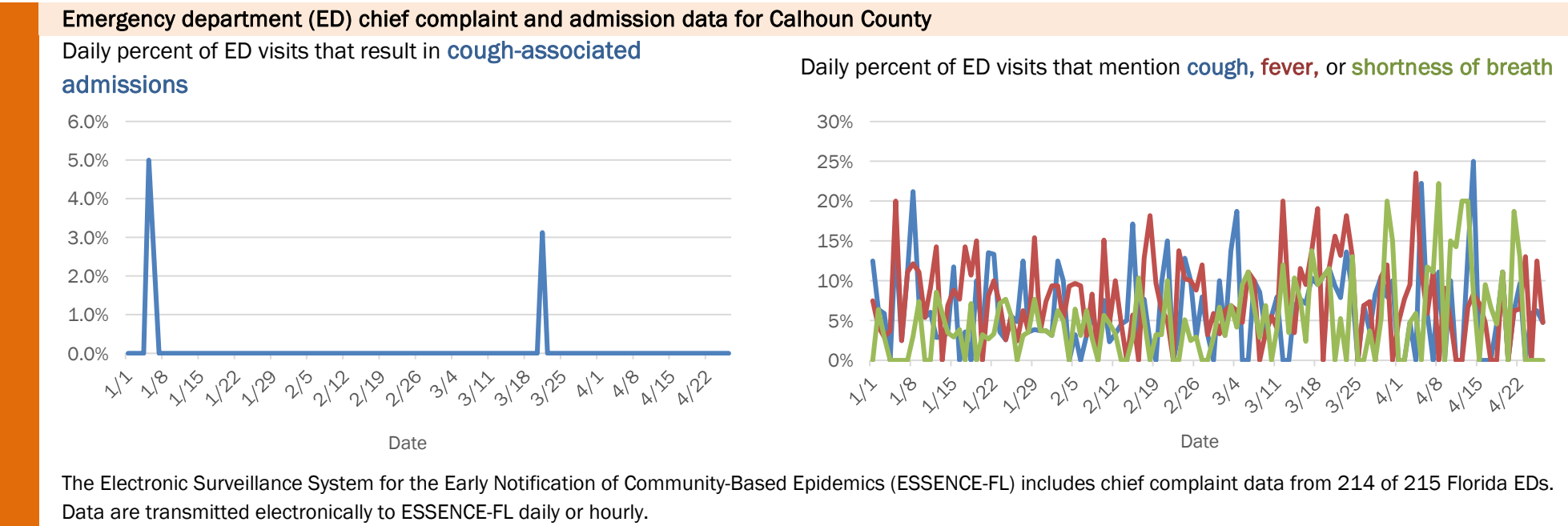
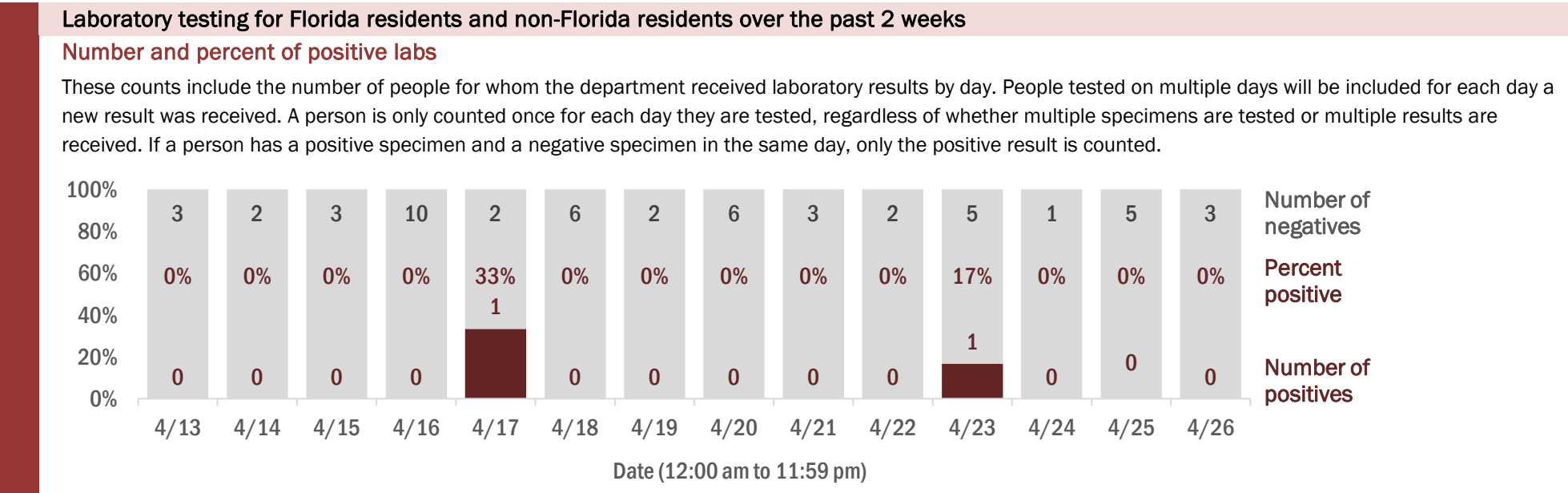
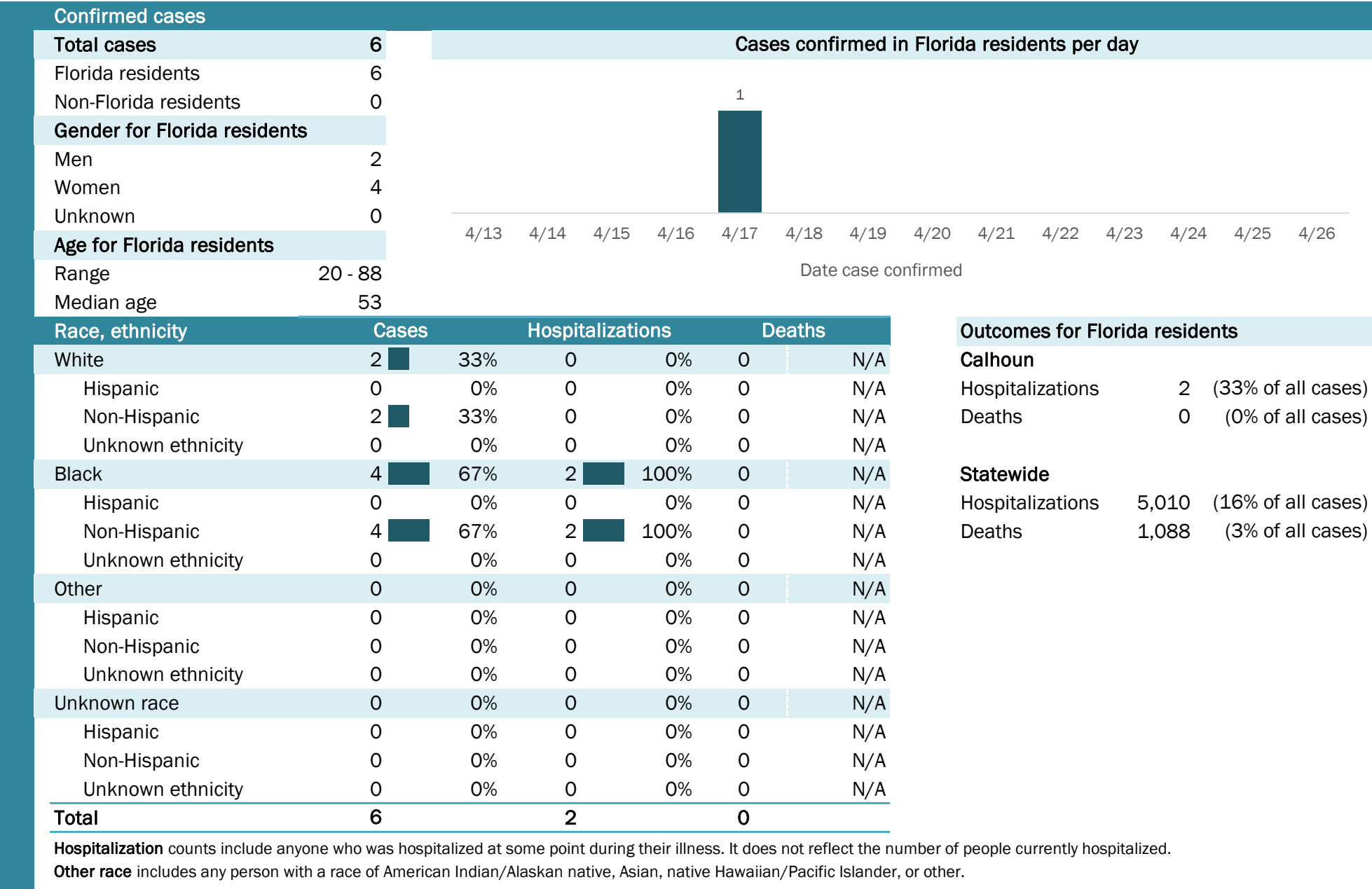

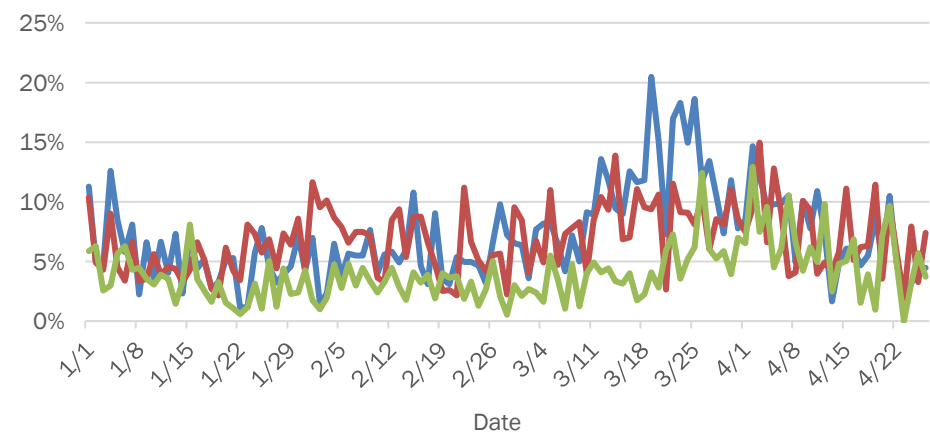


Emergency department (ED) chief complaint and admission data for Columbia County

Daily percent of ED visits that mention cough, fever, or shortness of breath

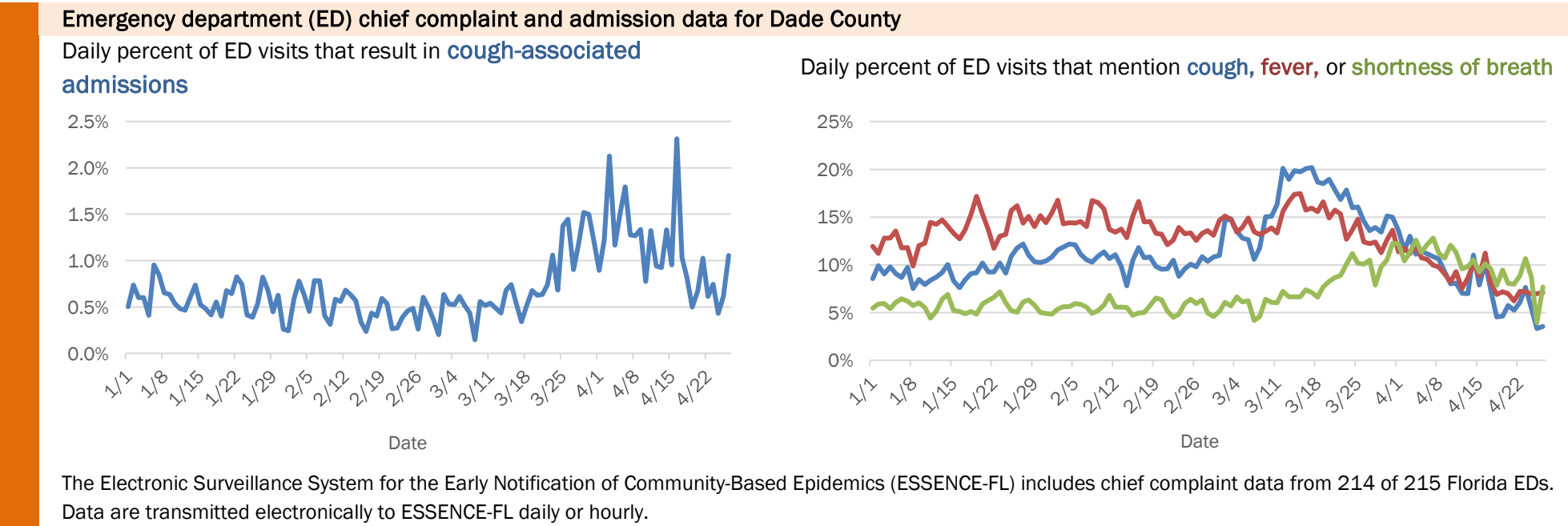
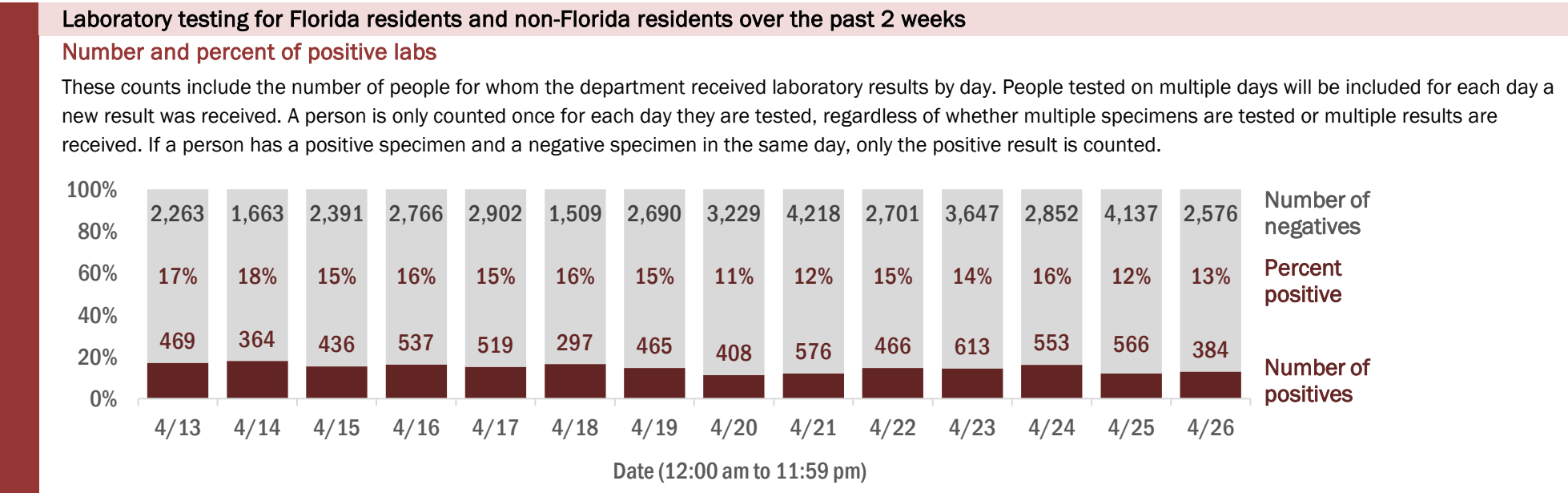
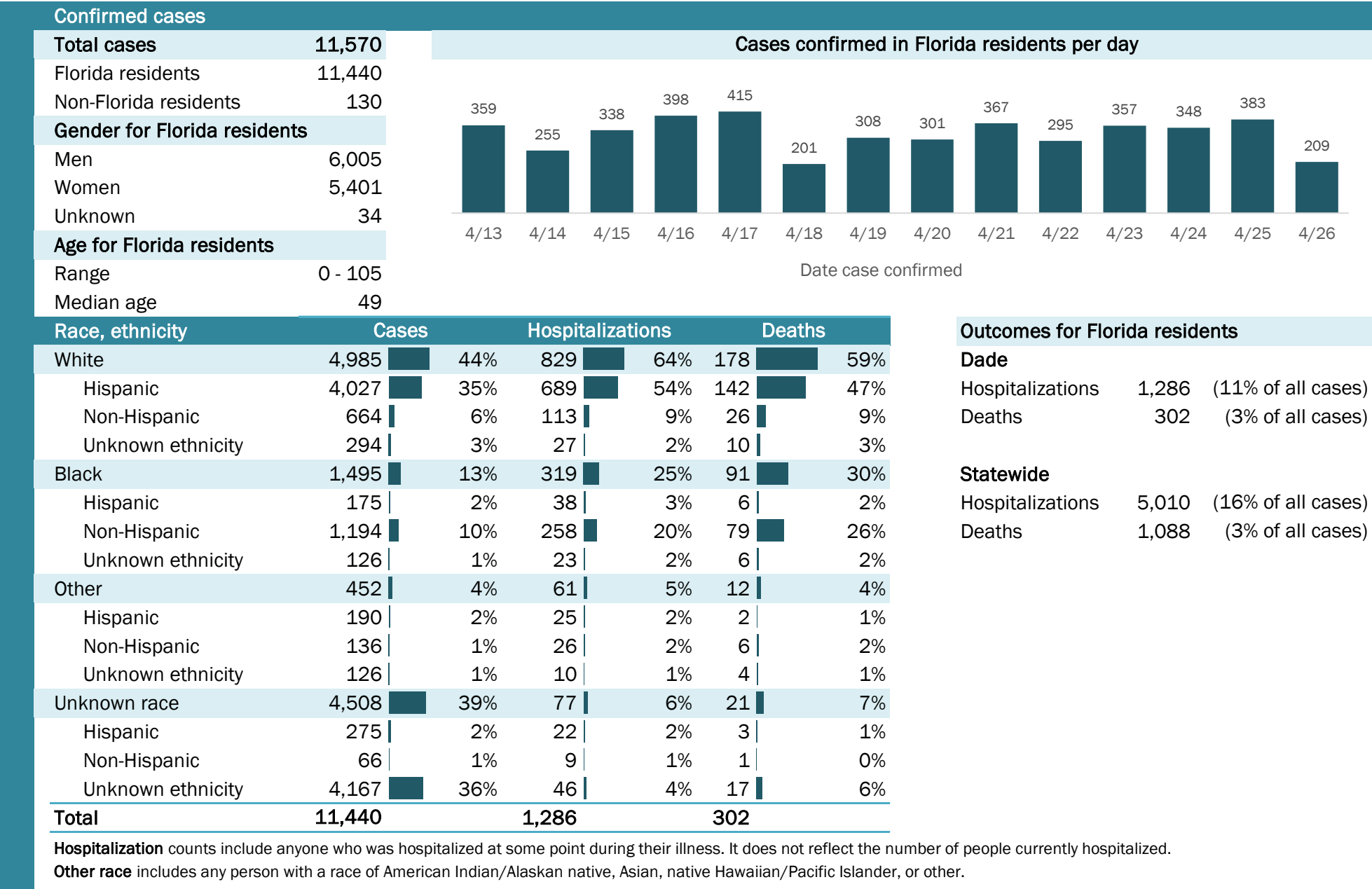

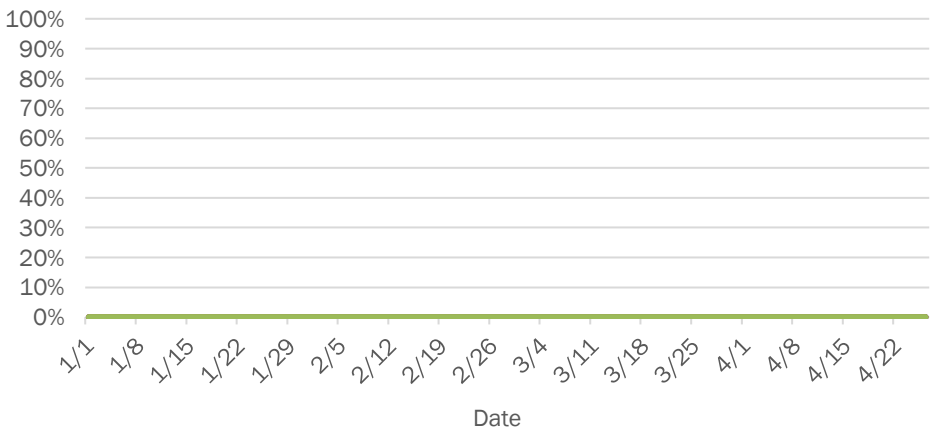


Emergency department (ED) chief complaint and admission data for Franklin County

Daily percent of ED visits that mention cough, fever, or shortness of breath

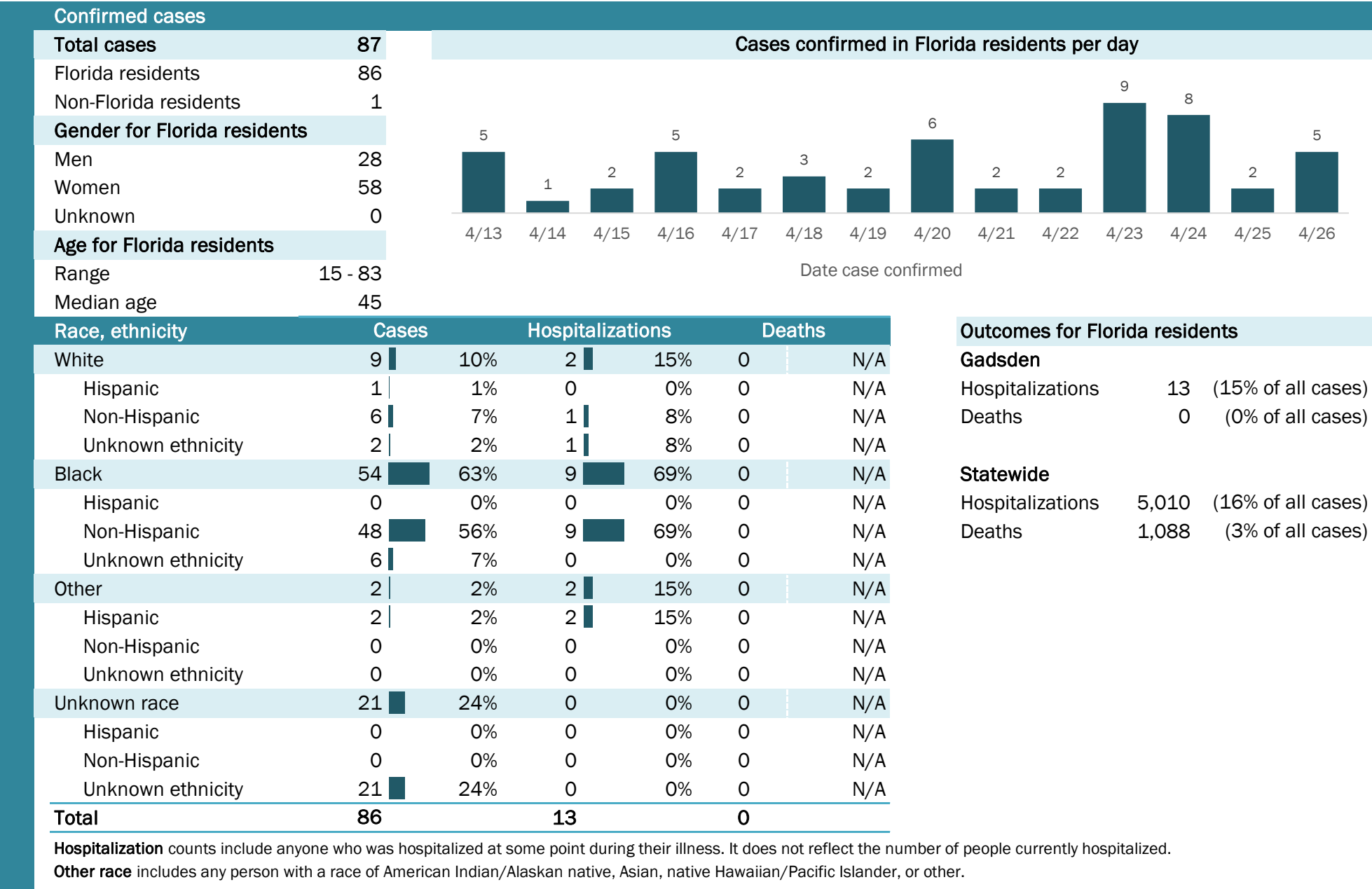

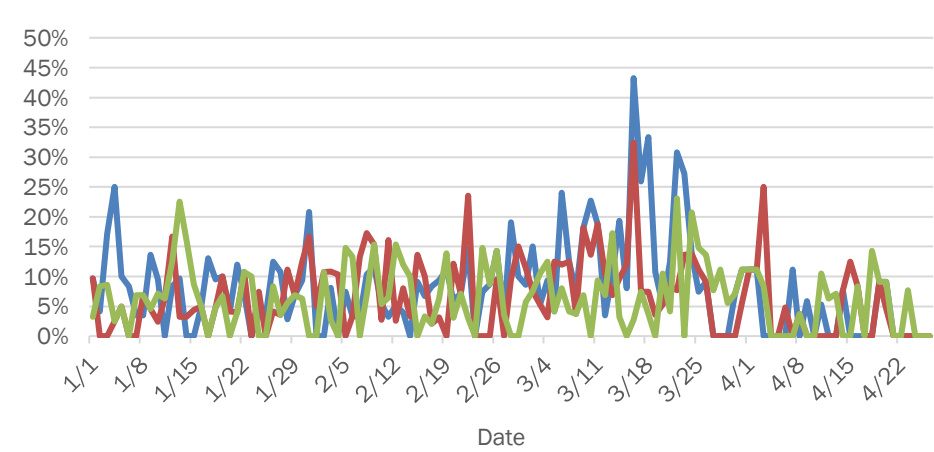


Emergency department (ED) chief complaint and admission data for Gulf County

Daily percent of ED visits that mention cough, fever, or shortness of breath

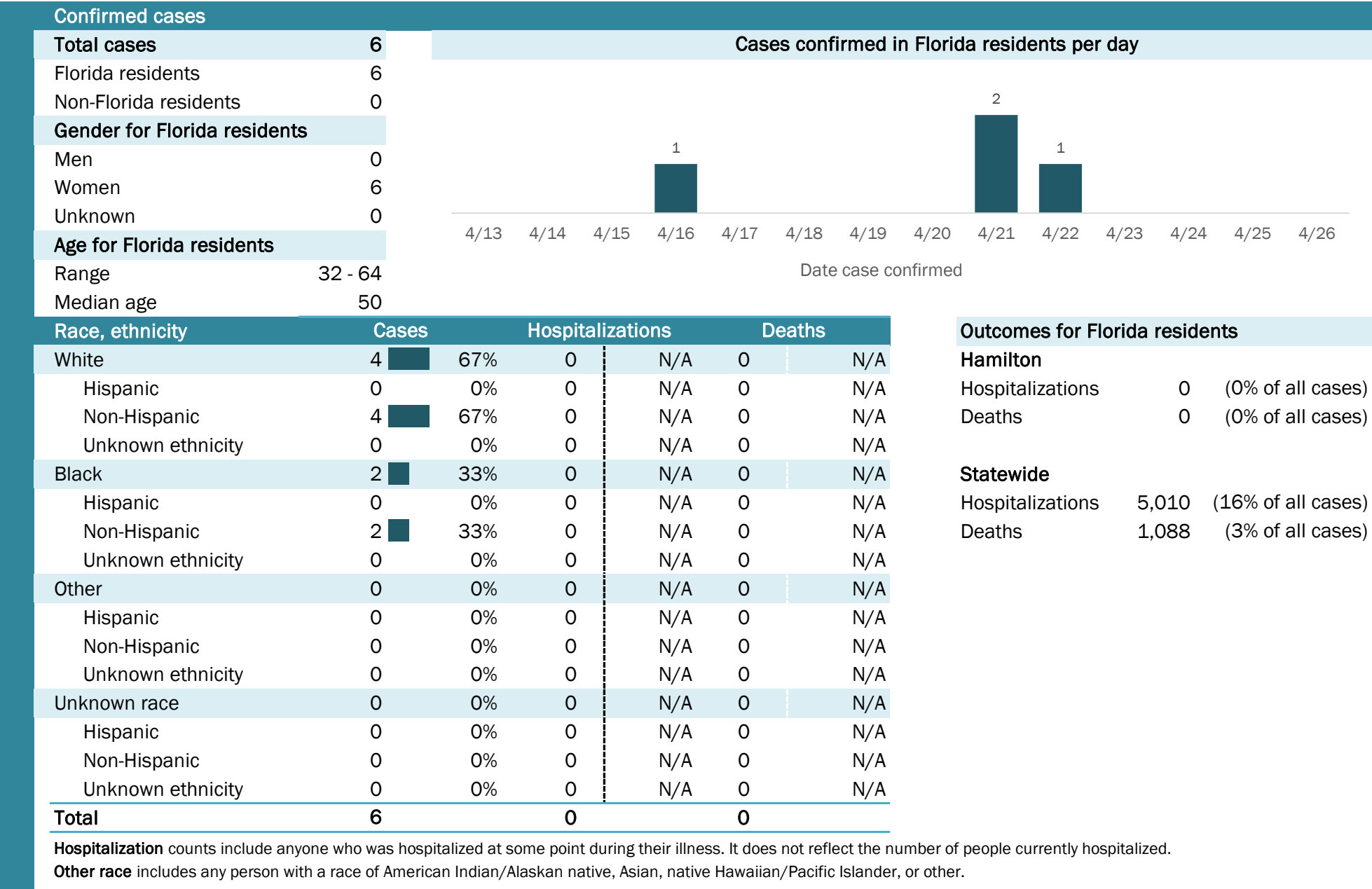

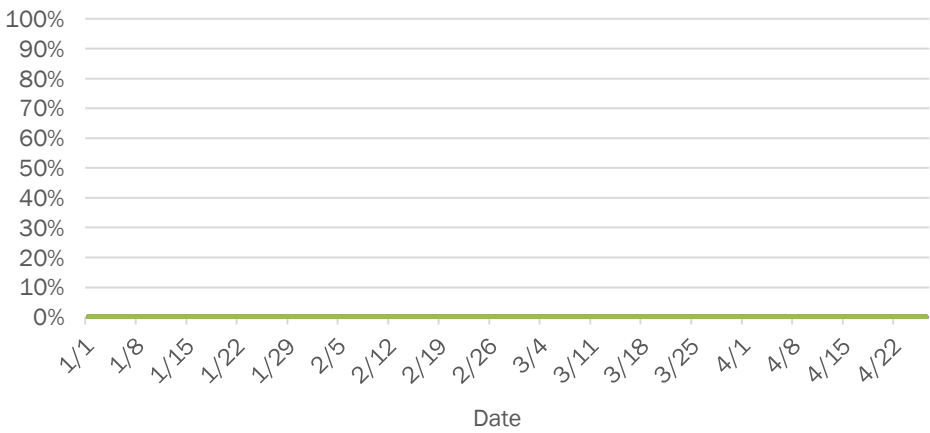


Emergency department (ED) chief complaint and admission data for Hamilton County

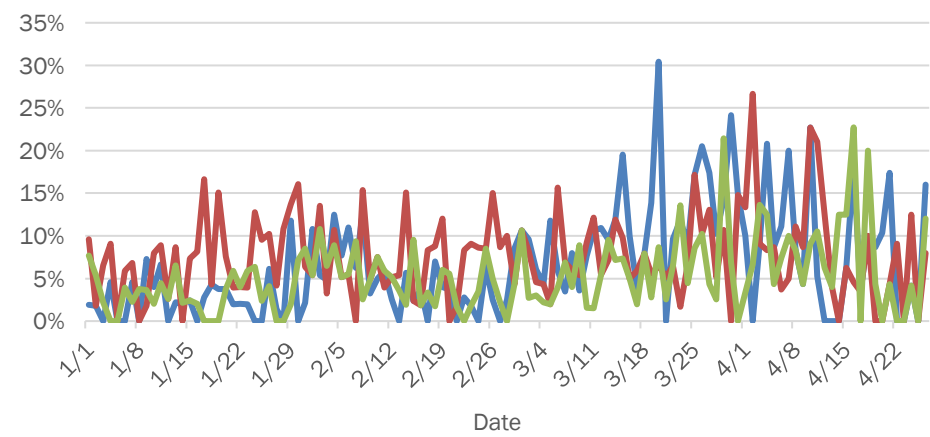


Emergency department (ED) chief complaint and admission data for Hendry County

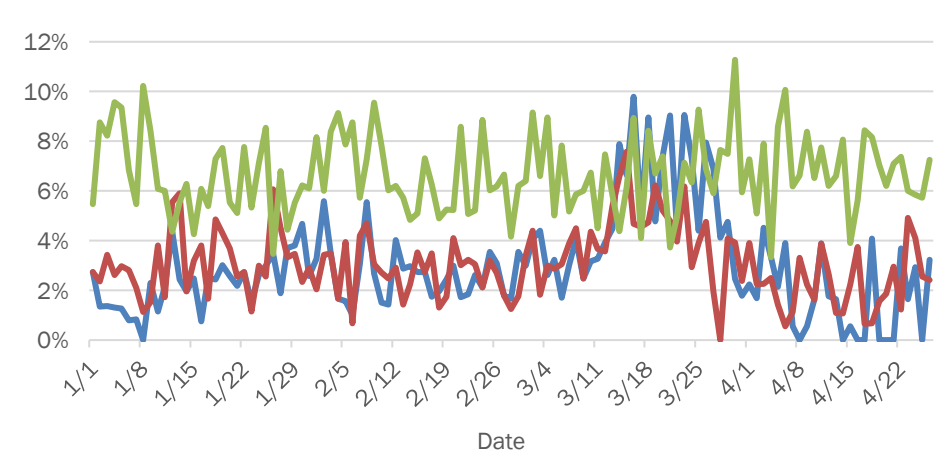


Emergency department (ED) chief complaint and admission data for Indian River County

Daily percent of ED visits that mention cough, fever, or shortness of breath

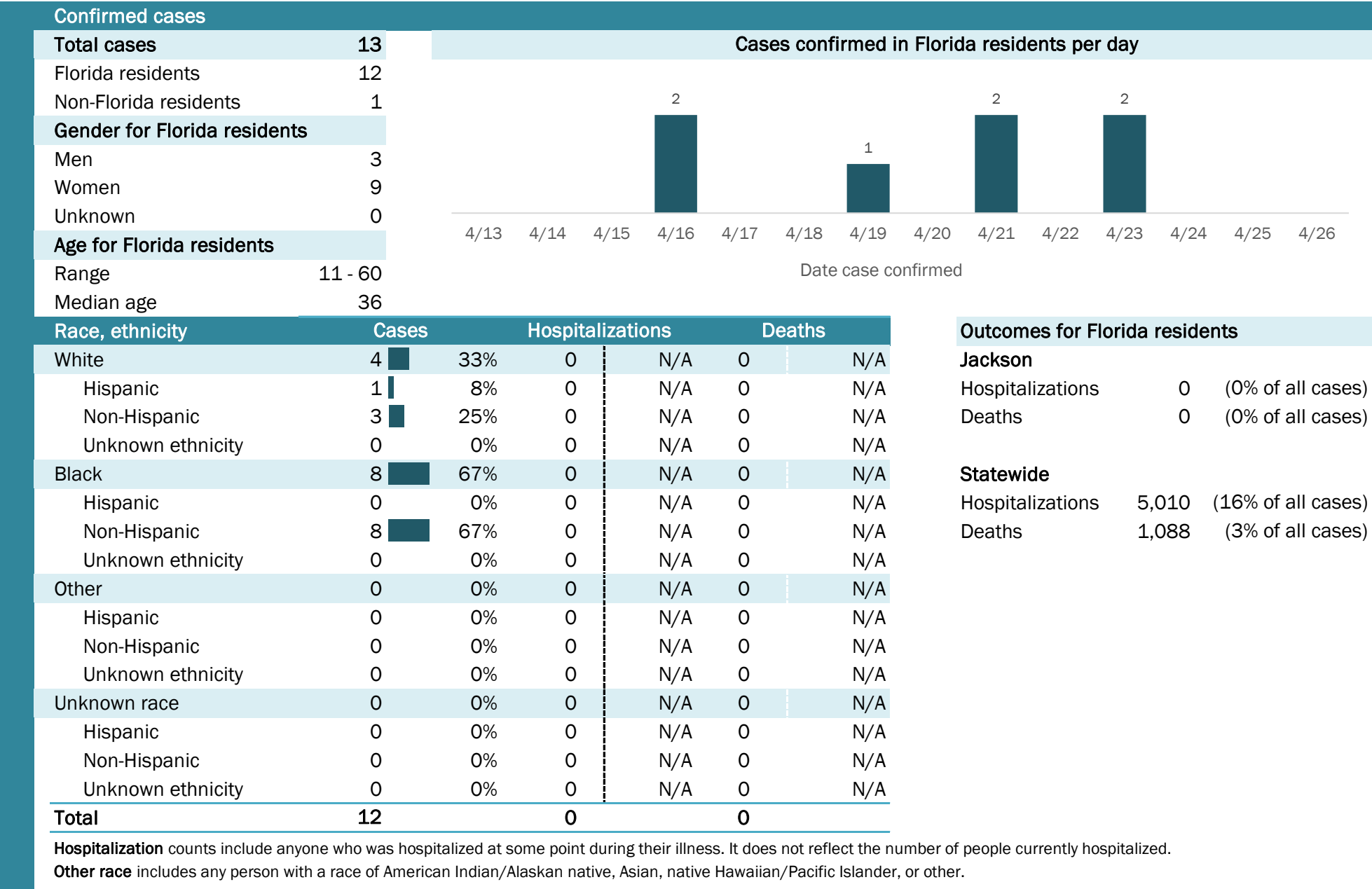

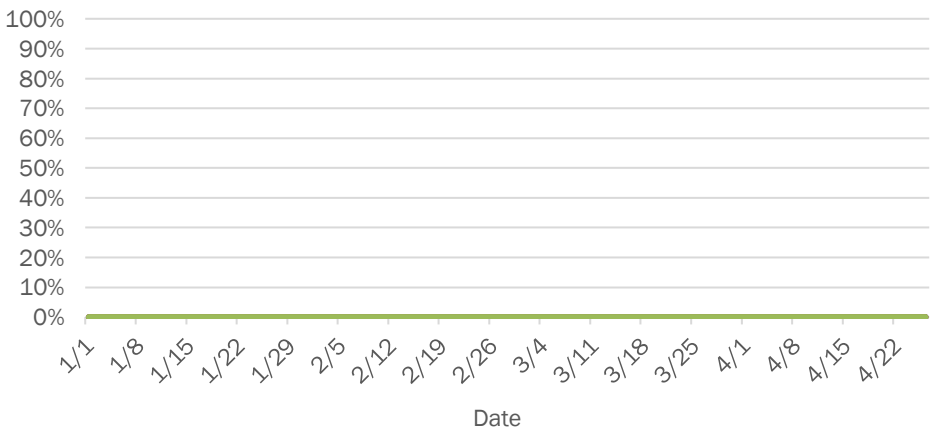


Emergency department (ED) chief complaint and admission data for Liberty County

Daily percent of ED visits that mention cough, fever, or shortness of breath

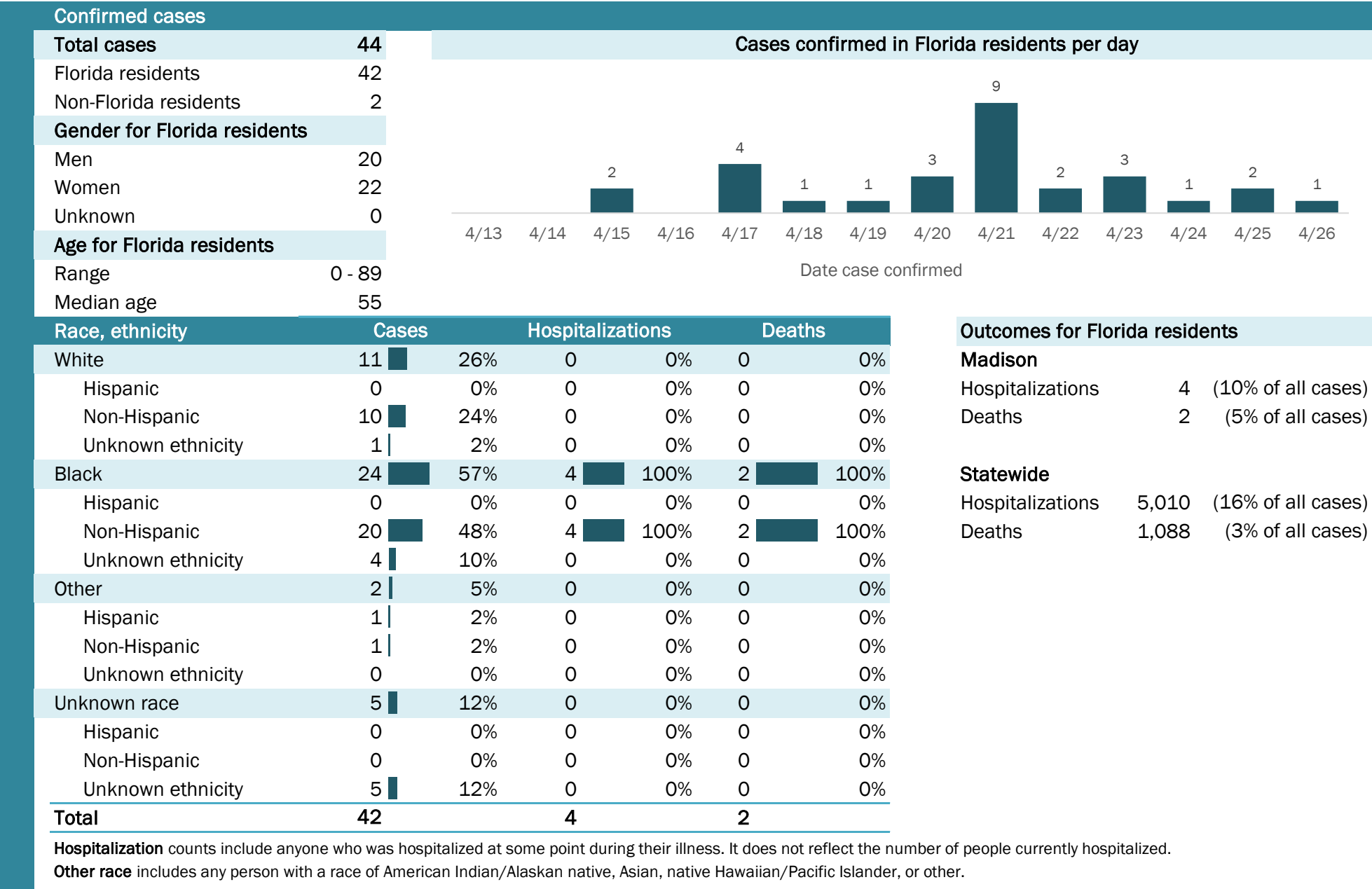

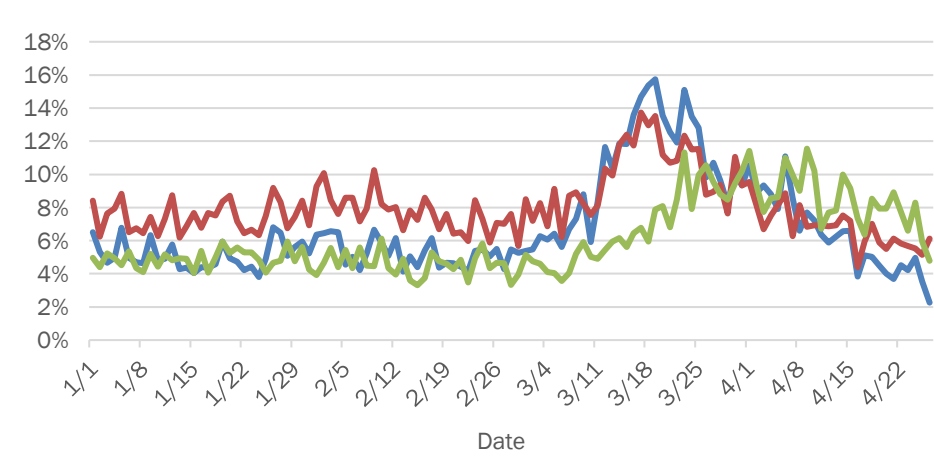


Emergency department (ED) chief complaint and admission data for Palm Beach County

Daily percent of ED visits that mention cough, fever, or shortness of breath

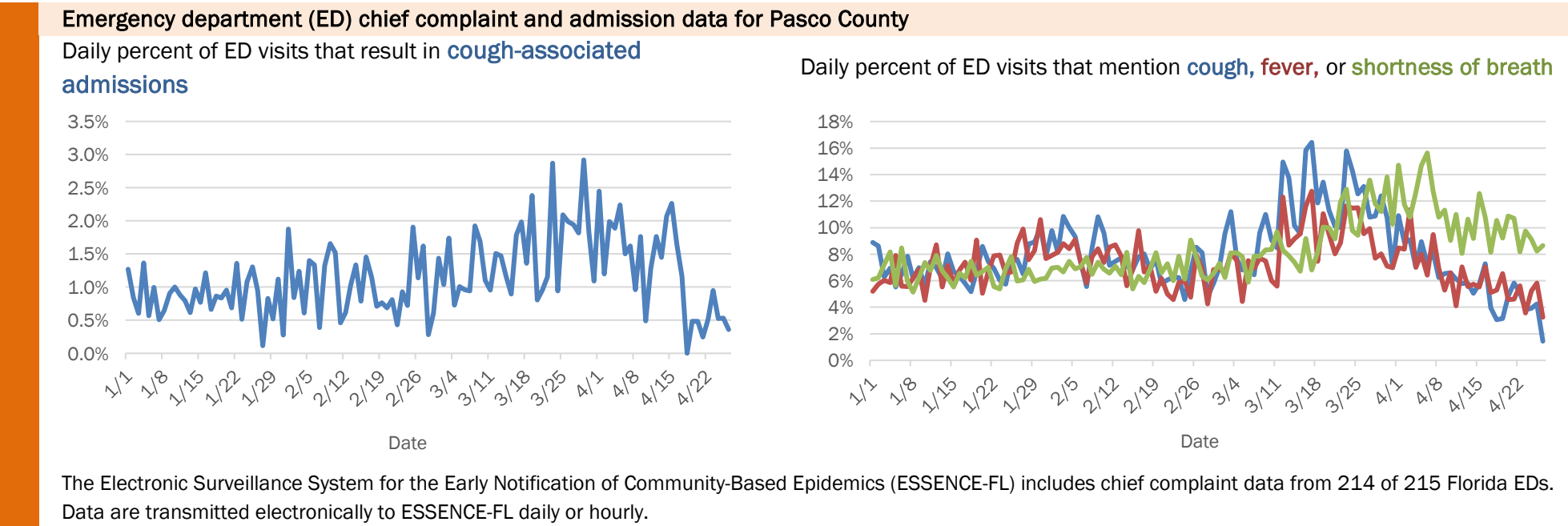
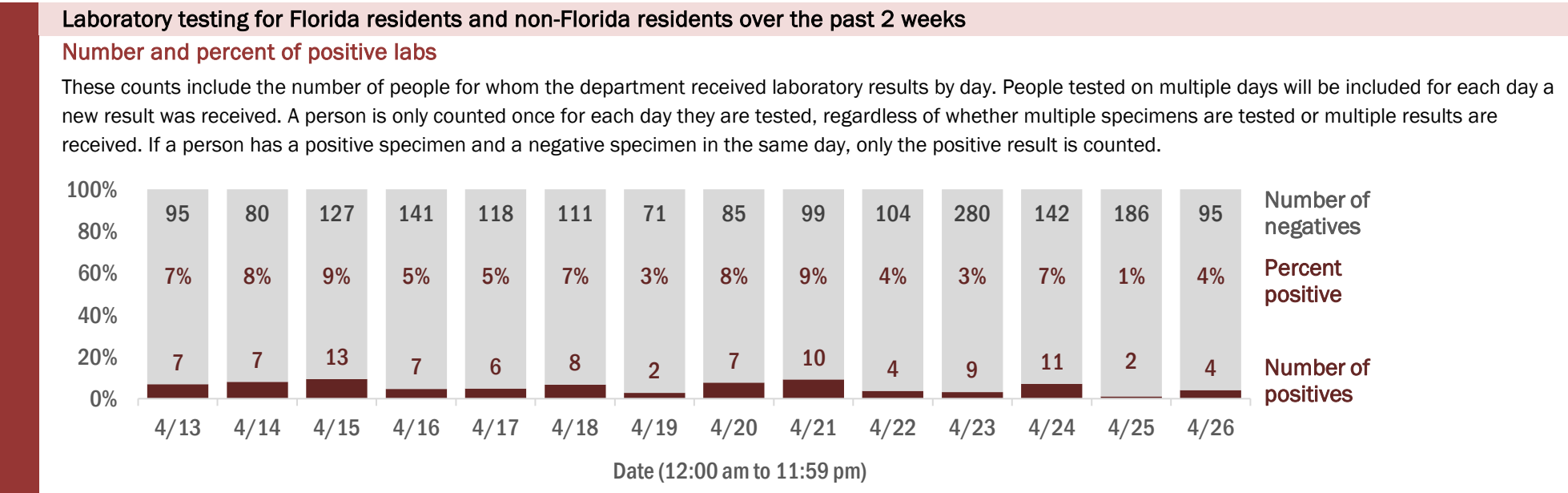
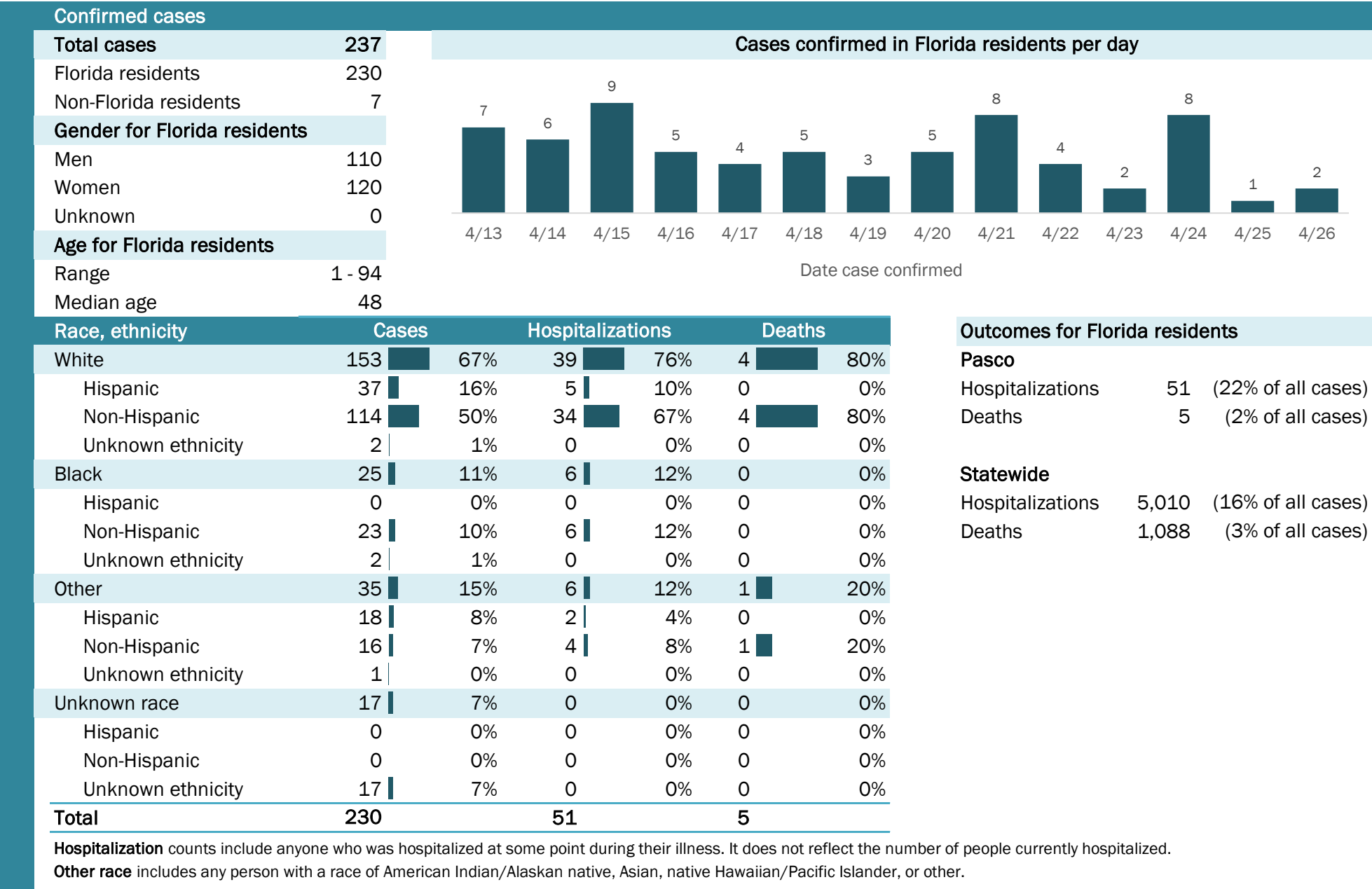

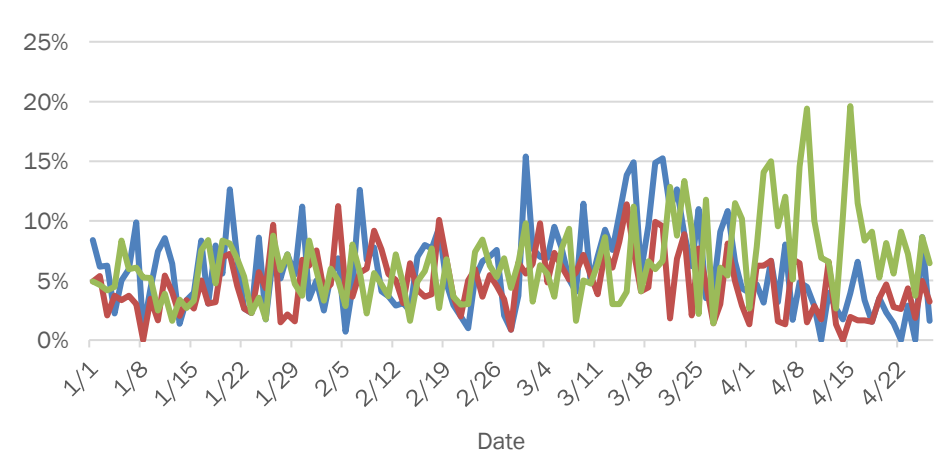


Emergency department (ED) chief complaint and admission data for Putnam County

Daily percent of ED visits that mention cough, fever, or shortness of breath

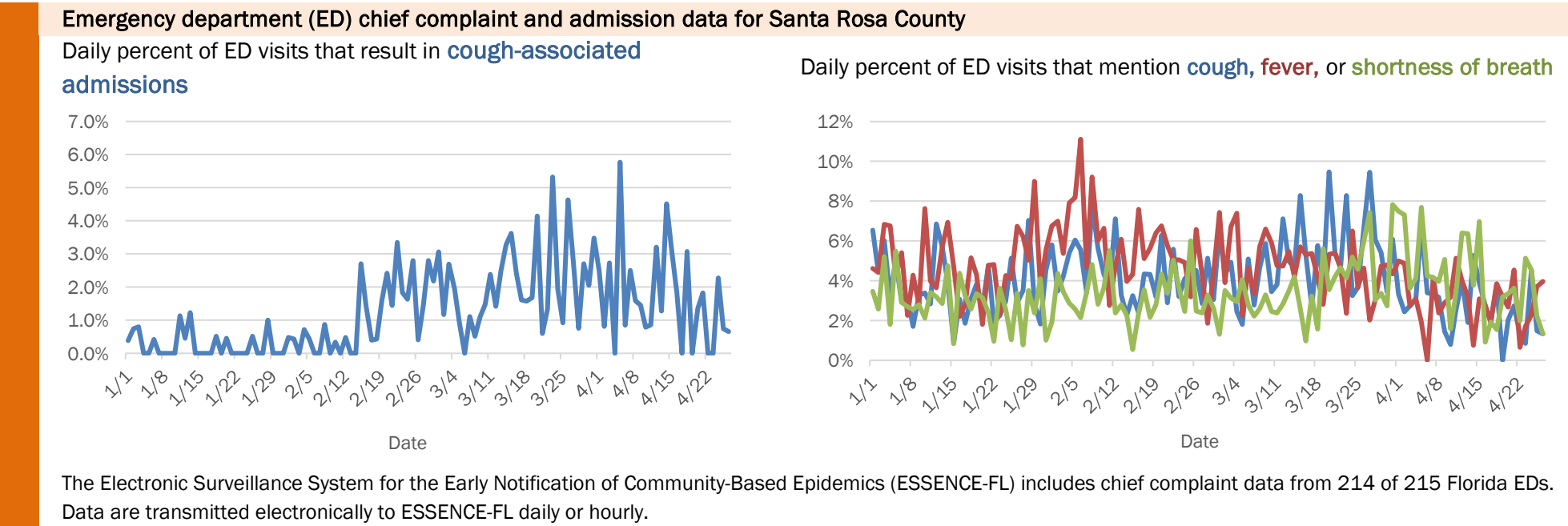
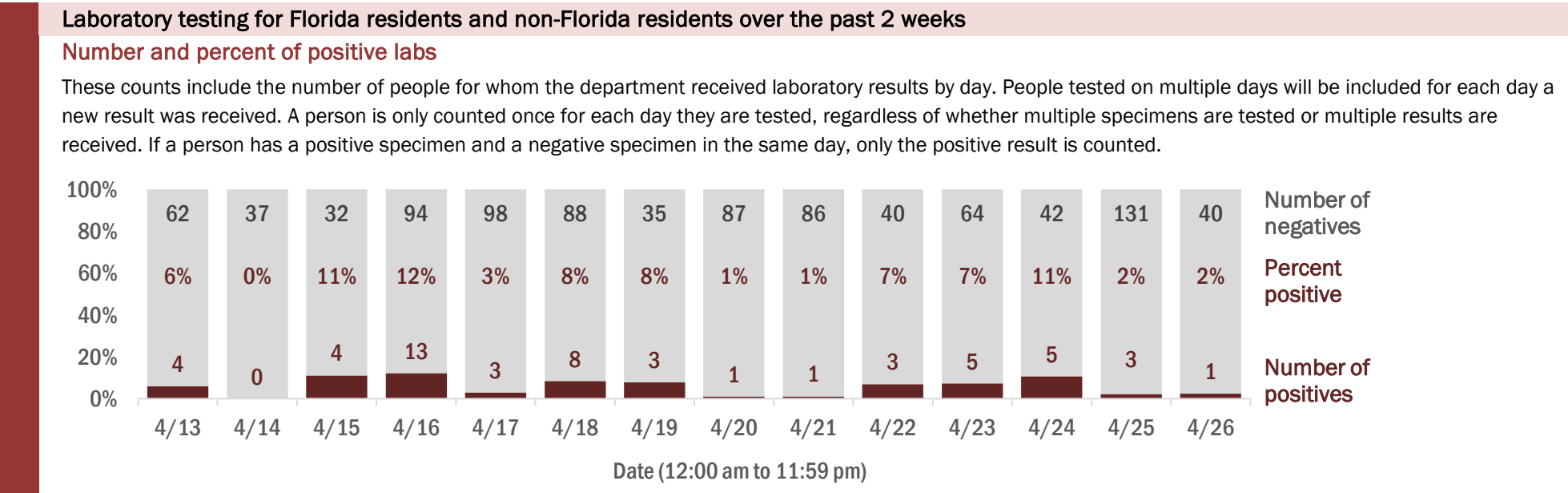
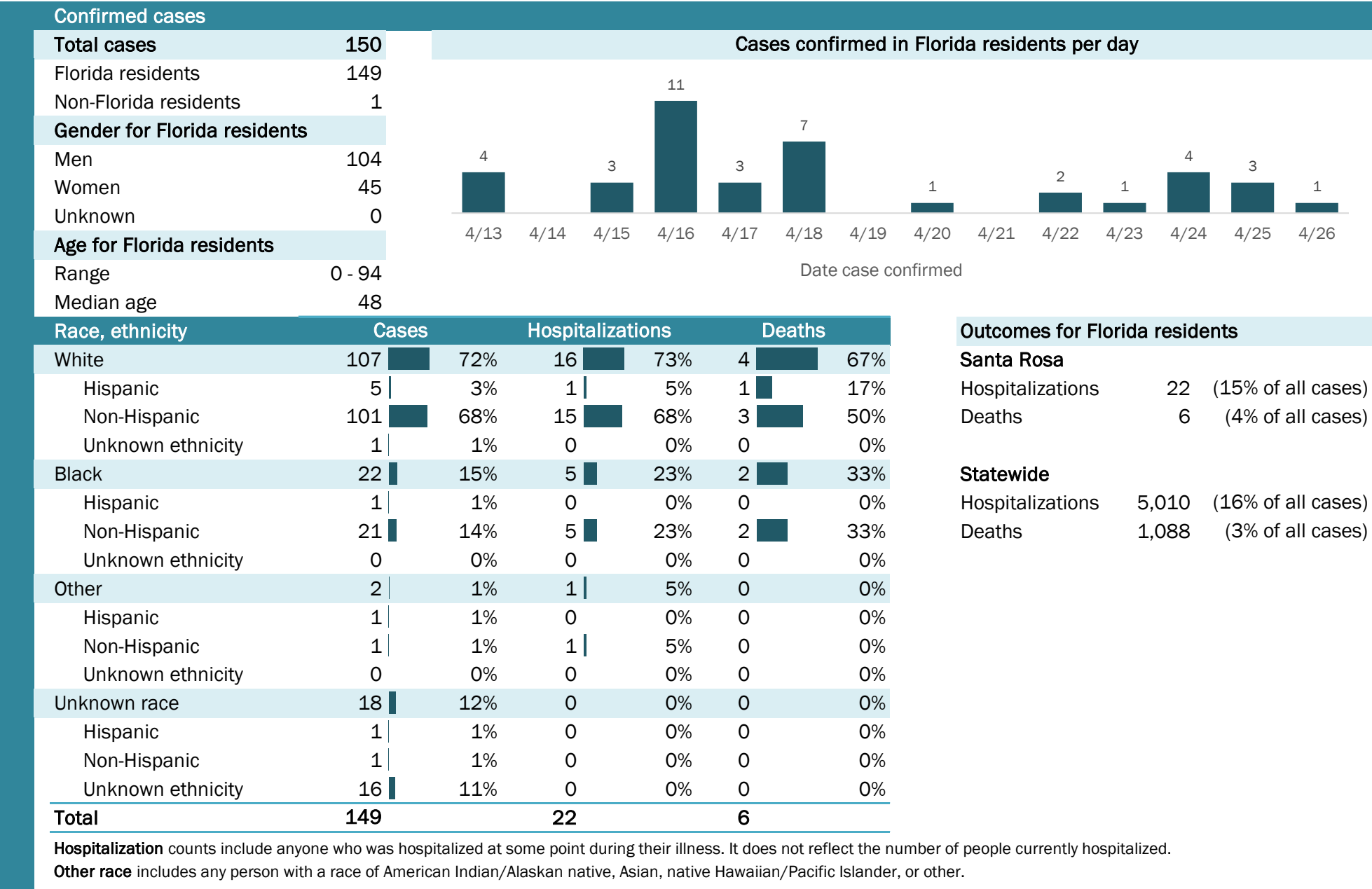

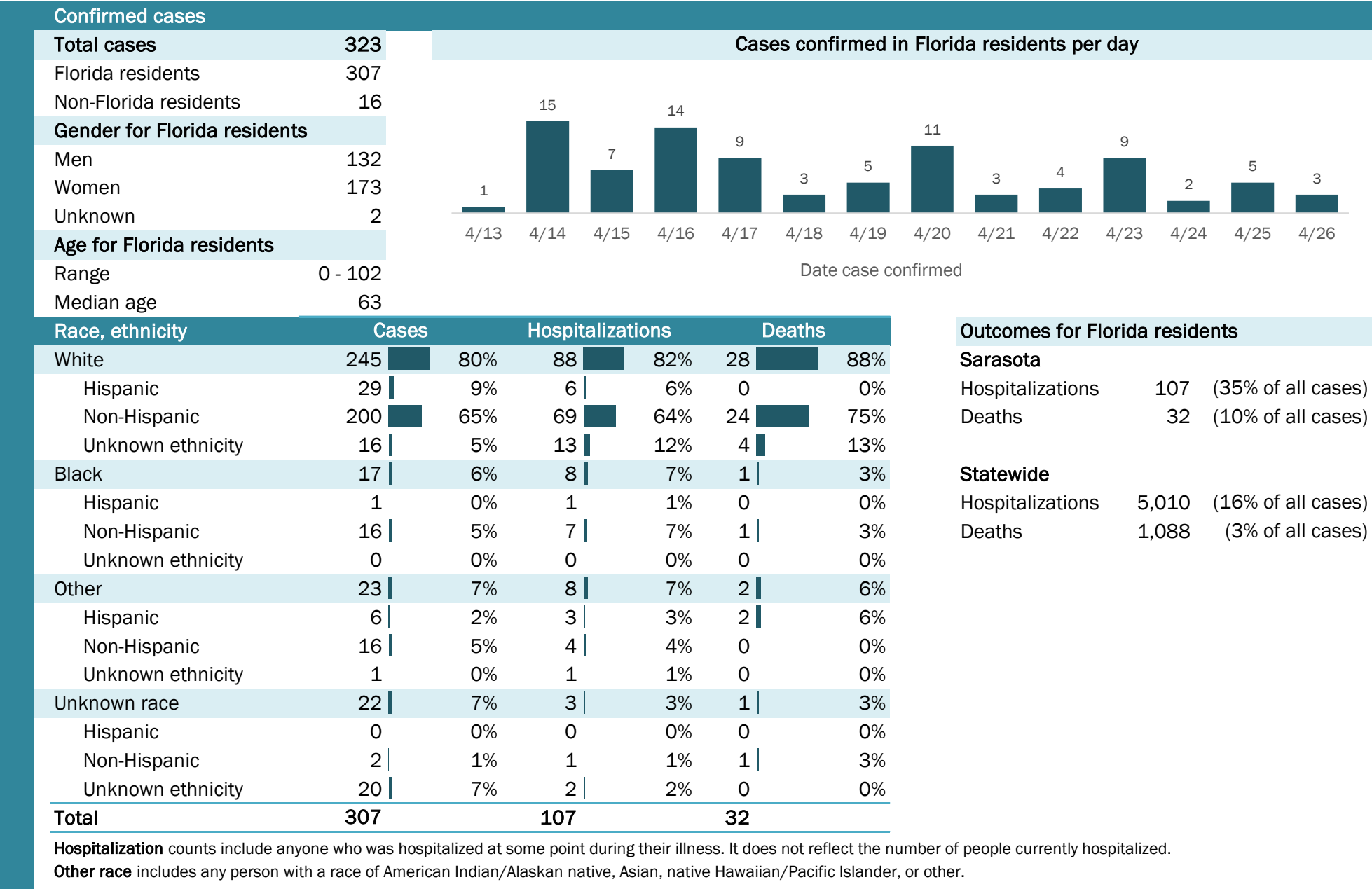

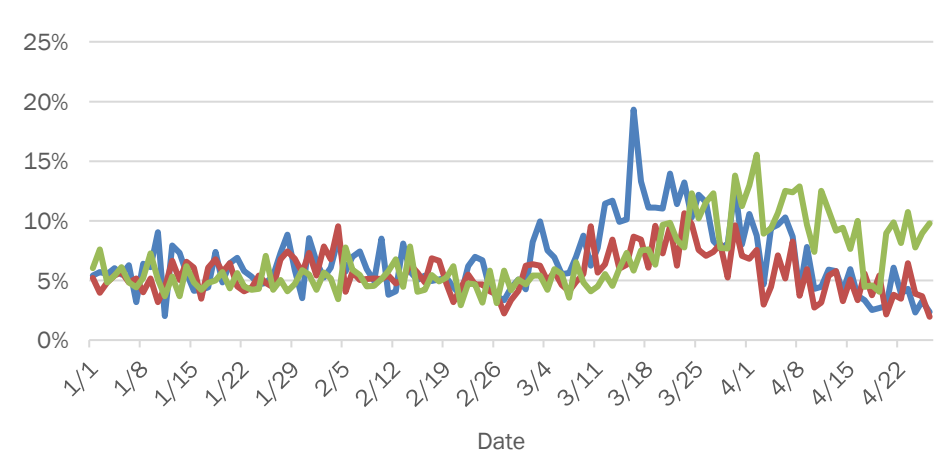


Emergency department (ED) chief complaint and admission data for Seminole County

Daily percent of ED visits that mention cough, fever, or shortness of breath

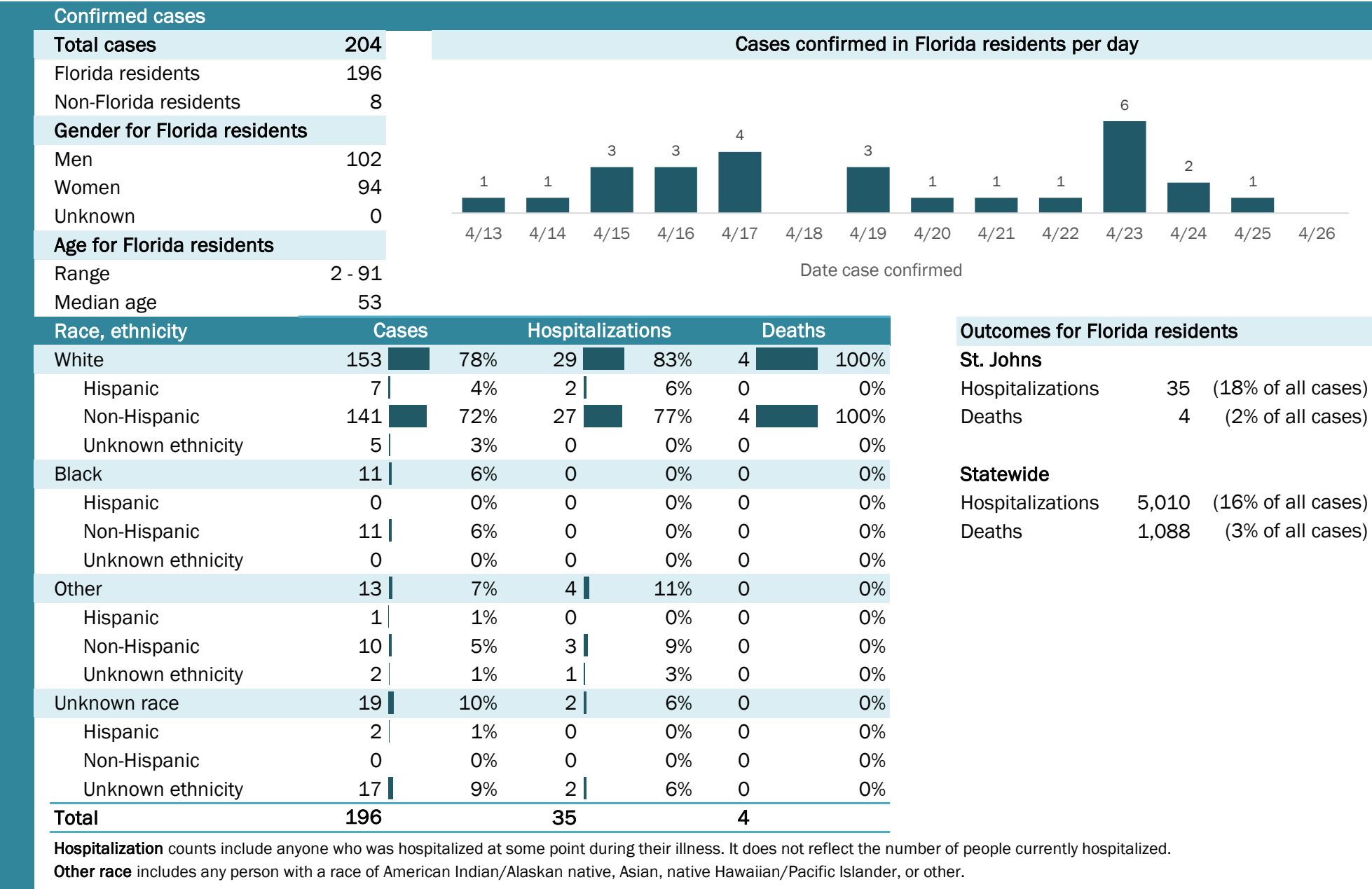

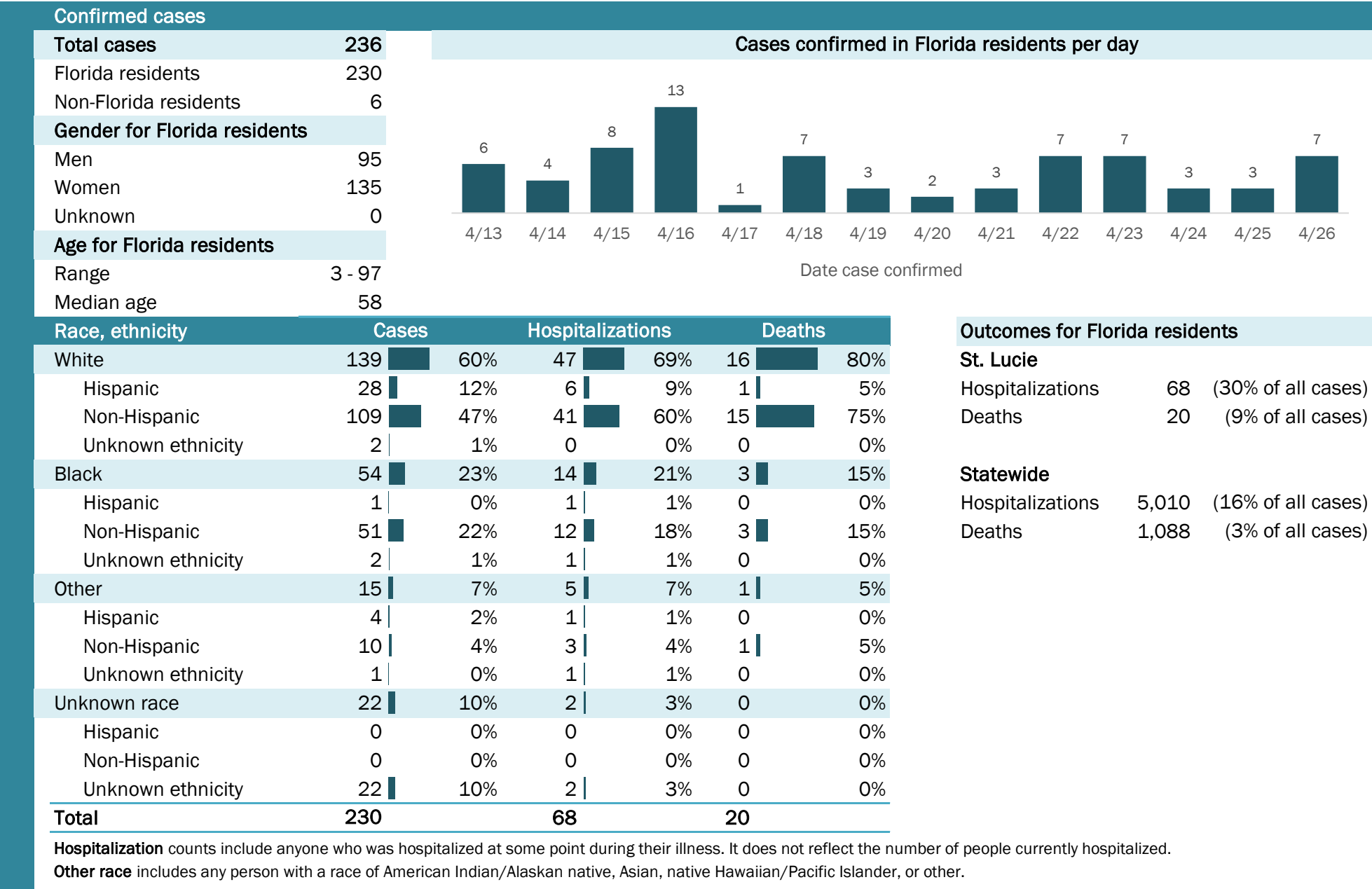

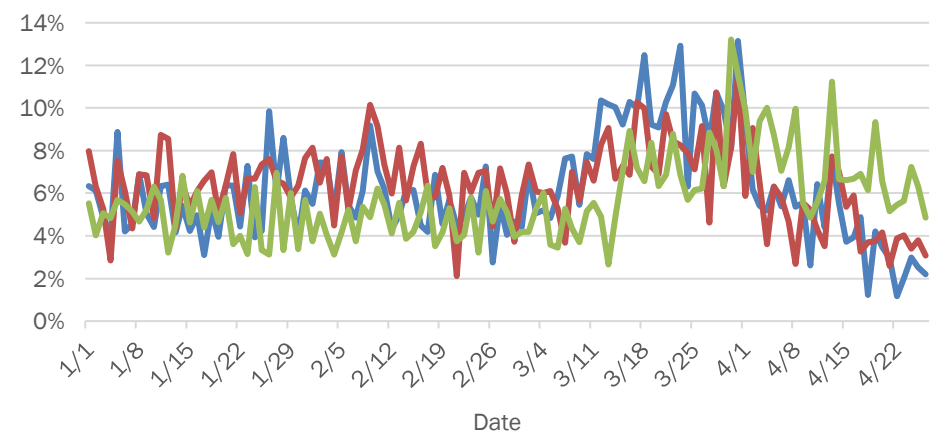


Emergency department (ED) chief complaint and admission data for St. Lucie County

Daily percent of ED visits that mention cough, fever, or shortness of breath

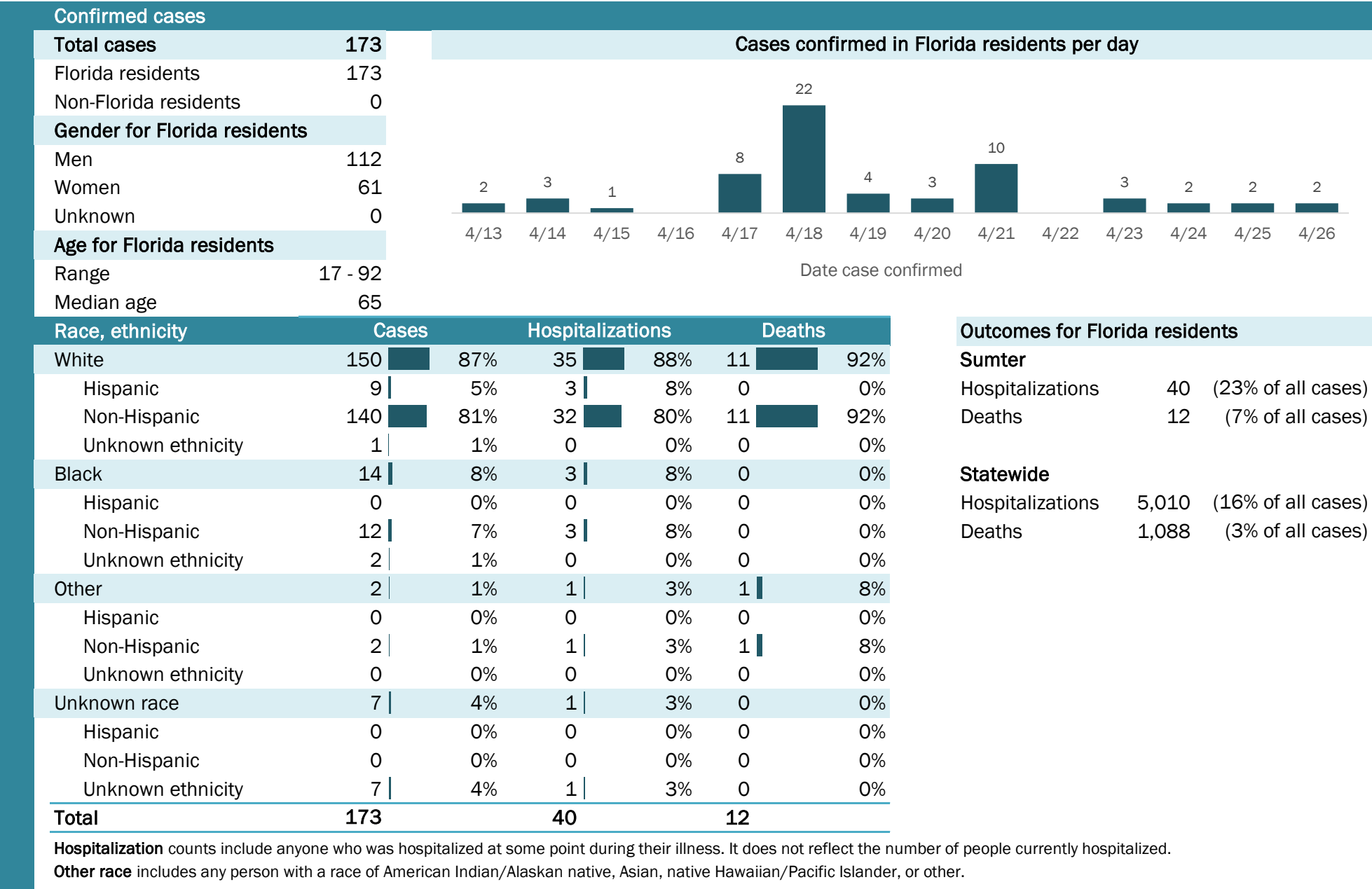

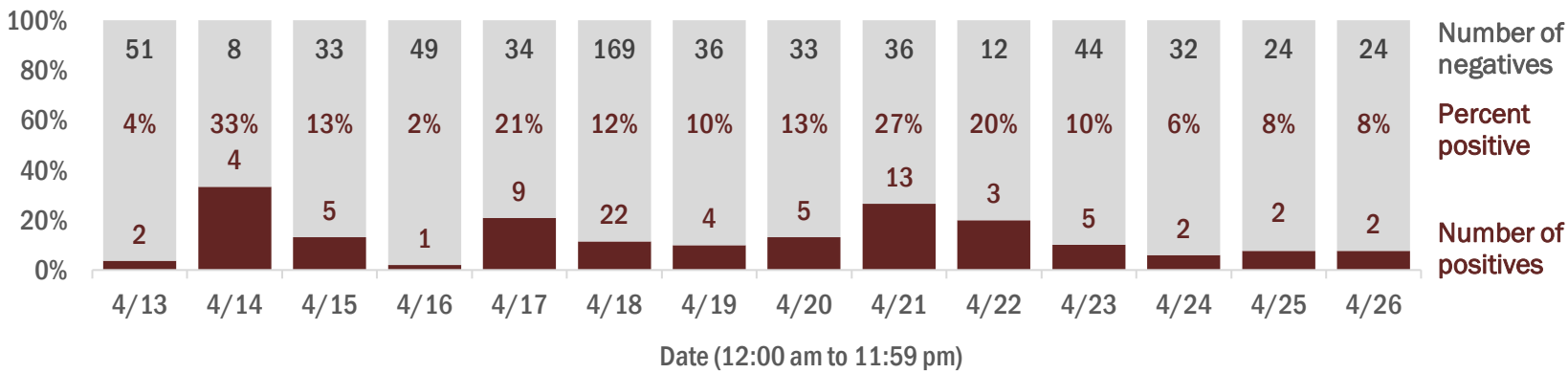

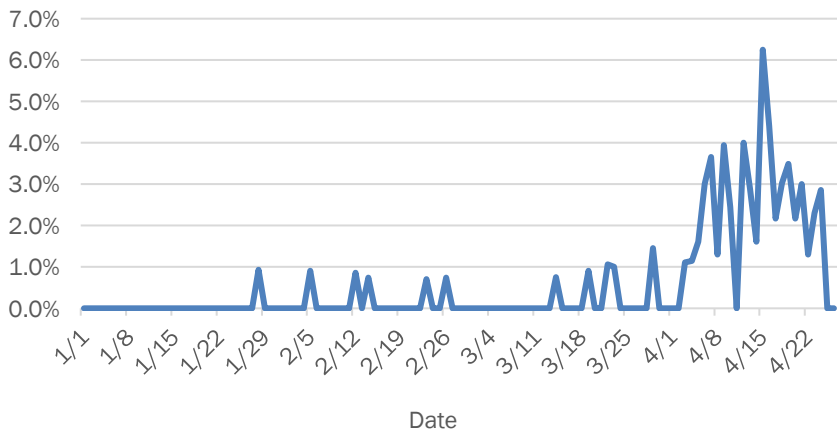

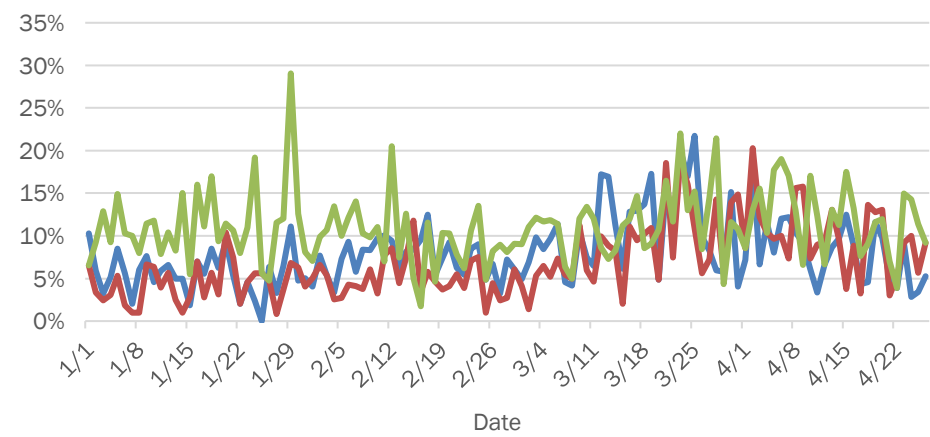


Emergency department (ED) chief complaint and admission data for Sumter County
