

Emergency department (ED) chief complaint and admission data for Volusia County Daily percent of ED visits mentioning cough, fever, or shortness of breath








Emergency department (ED) chief complaint and admission data for Wakulla County












Emergency department (ED) chief complaint and admission data for Walton County






Weekly count of ED vists for influenza-like illness 35 30 25 20 15 10 5 Week start date






