Daily percent of ED visits mentioning





Daily percent of ED visits mentioning





Daily percent of ED visits mentioning





Daily percent of ED visits mentioning











## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Putnam County



Daily percent of ED visits mentioning






## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Santa Rosa County



Daily percent of ED visits mentioning









## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Suwannee County



Daily percent of ED visits mentioning









## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Taylor County



Daily percent of ED visits mentioning









## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Volusia County



Daily percent of ED visits mentioning









## Emergency department (ED) and freestanding ED (FSED) chief complaint and admission data for Wakulla County



Daily percent of ED visits mentioning




